

URSO, between September 8, 2011 and April 23, 2014, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, with purpose to deprive the owner of property, to wit: "R.H.", and the value of the property is \$1,000.00 or more and is less than \$7,500.00, did knowingly obtain or exert control over said property, by deception, contrary to and in violation of Ohio Revised Code Section 2913.02(A)(3), and against the peace and dignity of the State of Ohio. (Theft, a felony of the fifth degree)



URSO, between August 19, 2011 and April 23, 2014, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, with purpose to deprive the owner of property, to wit: "D.D.", and the value of the property is \$1,000.00 or more and is less than \$7,500.00, did knowingly obtain or exert control over said property, by deception, contrary to and in violation of Ohio Revised Code Section 2913.02(A)(3), and against the peace and dignity of the State of Ohio. (Theft, a felony of the fifth degree)

COUNT 3: JAMES B. FETTER aka JAMES A. URSO, between August 8, 2011 and April 23, 2014, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, with purpose to deprive the owner of property, to wit: "D.F.", and the value of the property is \$1,000.00 or more and is less than \$7,500.00, did knowingly obtain or exert control over said property, by deception, and the victim of the offense is an elderly person, contrary to and in violation of Ohio Revised Code Section 2913.02(A)(3), and against the peace and dignity of the State of Ohio. (Theft from an Elderly Person, a felony of the fourth degree)

COUNT 4: JAMES B. FETTER aka JAMES A. URSO, between May 20, 2011 and April 23, 2014, in Greene County, Ohio, or by some manner enumerated in Section 2901.12 of the Ohio Revised Code whereby proper venue is placed in Greene County, Ohio, with purpose to deprive the owner of property, to wit: "D.R.", and the value of the property is \$1,000.00 or more and is less than \$7,500.00, did knowingly obtain or exert control over said property, by deception, contrary to and in violation of Ohio Revised Code Section 2913.02(A)(3), and against the peace and dignity of the State of Ohio. (Theft, a felony of the fifth degree)
