COUNT ONE

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that from on or about the 18th day of June, 2021 to on or about the 19th day of January 2022, in Clinton County, Ohio, Michael S. Foster, with purpose to deprive the owner of certain property or services worth \$7,500 or more but less than \$150,000, to wit: \$50,500 UNITED STATES CURRENCY belonging to Peggy Hart, did knowingly obtain or exert control over such property or services beyond the scope of the express or implied consent of the owner or person authorized to give consent, and at the time, the said victim was an elderly person, in violation of Section 2913.02 (A)(2) of the Ohio Revised Code (Theft From a Person in a Protected Class, a felony of the third degree) and against the peace and dignity of the State of Ohio.

COUNT TWO

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that from on or about the 18th day of June, 2021 to on or about the 19th day of January 2022, in Clinton County, Ohio, Michael S. Foster, with purpose to deprive the owner of certain property or services worth \$7,500 or more but less than \$150,000, to wit:


\$50,500 UNITED STATES CURRENCY belonging to Peggy Hart, did knowingly obtain or exert control over such property or services by deception, and at the time, the said victim was an elderly person, in violation of Section 2913.02 (A)(3) of the Ohio Revised Code (Theft From a Person in a Protected Class, a felony of the third degree) and against the peace and dignity of the State of Ohio.

COUNT THREE

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that from on or about the 18th day of June, 2021 to on or about the 19th day of January 2022, in Clinton County, Ohio, Michael S. Foster, having devised a scheme to defraud, knowingly disseminated, transmitted, or caused to be disseminated or transmitted by means of a wire, radio, satellite, telecommunication, telecommunications device, telecommunications service, or voice over internet protocol service, any writing, data, sign, signal, picture, sound, or image, to wit: TEXT MESSAGES, with purpose to execute or otherwise further the scheme to defraud, and the value of the benefit obtained by the defendant or of the detriment to the victim or victims of the fraud is \$7,500 or more but less than \$150,000, in violation of Section 2913.05(A) of the Ohio Revised Code (Telecommunications Fraud, a felony of the third degree) and against the peace and dignity of the State of Ohio.
