I have personal knowledge of the facts listed in the statement of facts as I was involved in the underlying investigation and/or arrest.


I have knowledge of the facts listed in statement of facts based on my review of available Columbus Division of Police Reports, which were completed by Columbus Division of Police Officers acting in their official capacity and as a part of their official duties.

**Summary Statement of Facts in Support of Probable Cause:**


In August of 2021 the Central Ohio Human Trafficking Task Force (COHTTF) received multiple tips regarding a minor female that was possibly a sex trafficking victim. As the case was progressed through interviews, subpoenas and cellphone analysis a male named Robert D. Pea (DOB: 08/29/1961) was identified as a person of interest. On October 25, 2021 Pea was interviewed by Task Force Agents regarding his involvement with the possible exploitation of a minor female victim. Information obtained during the interview, along with additional evidence already analyzed provided investigators with probable cause to file a Compelling Prostitution charge on Robert Pea.

On October 27, 2021 an arrest warrant was subsequently filed and issued for Robert D. Pea through the Franklin County Municipal Court Clerks Office.
