INDICTMENT

The Grand Jurors of this County, in the name and by the authority of the State of Ohio, upon their oath, do find and present that:

COUNT I

Alan K. Laney, 47, 222 ½ Broad Street, Montpelier, Ohio 43543, at Williams County, Ohio, on or about the 5th day of June 2017, did violate Ohio Revised Code §2903.11(A)(1)(D)(1)(a), Felonious Assault, a felony of the second degree, in that he

Did knowingly cause serious physical harm to another, Jane Doe, seventeen months old,

all against the peace and dignity of the State of Ohio.

COUNT II

Alan K. Laney, 47, 222 ½ Broad Street, Montpelier, Ohio 43543, at Williams County, Ohio, on or about the 5th day of June 2017, did violate Ohio Revised Code §2903.11(A)(1)(D)(1)(a), Felonious Assault, a felony of the second degree, in that he

Did knowingly cause serious physical harm to another, Jane Doe, seventeen months old,

all against the peace and dignity of the State of Ohio.

COUNT III

Alan K. Laney, 47, 222 ½ Broad Street, Montpelier, Ohio 43543, at Williams County, Ohio, on or about the 5th day of June 2017, did violate Ohio Revised Code §2919.22(B)(1)(E)(2)(d), Endangering Children, a felony of the second degree, in that he

Did recklessly abuse a child under eighteen years of age, to-wit: Jane Doe, seventeen months old, which abuse resulted in serious physical harm to the child,

all against the peace and dignity of the State of Ohio.

COUNT IV

Alan K. Laney, 47, 222 ½ Broad Street, Montpelier, Ohio 43543, at Williams County, Ohio, on or about the 5th day of June 2017, did violate Ohio Revised Code §2919.22(B)(1)(E)(2)(d), Endangering Children, a felony of the second degree, in that he

Did recklessly abuse a child under eighteen years of age, to-wit: Jane Doe, seventeen months old, which abuse resulted in serious physical harm to the child,

all against the peace and dignity of the State of Ohio.

COUNT V

Alan K. Laney, 47, 222 ½ Broad Street, Montpelier, Ohio 43543, at Williams County, Ohio, on or about the 4th day of June 2017, did violate Ohio Revised Code §2919.22(B)(2)(E)(3), Endangering Children, a felony of the third degree, in that he

Did recklessly torture or cruelly abuse a child under eighteen years of age, to-wit: Jane Doe, seventeen months old,

all against the peace and dignity of the State of Ohio.

COUNT VI

Did recklessly, repeatedly administer unwarranted disciplinary measures to a child under eighteen years of age, to-wit: Jane Doe, seventeen months old, when there is a substantial risk that such conduct, if continued, will seriously impair or retard the child's mental health or development




