

being a law enforcement, ministerial, or judicial officer, negligently fail to perform a lawful duty in a criminal case or proceeding.

**TO WIT:**

Did fail to allow police reports to be filed or an investigation to commence after two (2) employees, K.M. and A.H., whom were both employed as peace officers at the time, personally reported to Robert Lampela in his public position that another employee allegedly sexually assaulted K.M. and A.H., on separate occasions within the jurisdiction of the Put-In-Bay Police Department. K.M. and A.H. stated that Robert Lampela advised them to get out of his office as "No (expletive deleted) whores would bring down his department" . The reason that Lampela chose to prevent any police investigation into the alleged sexual assaults was in order to prevent negative publicity for the Put-In-Bay Police Department and not due to an appropriate or acceptable purpose.

The offense was committed as a result of Lampela's misconduct in public office, as defined in R.C. 2901.13 (C)(1)(a).
