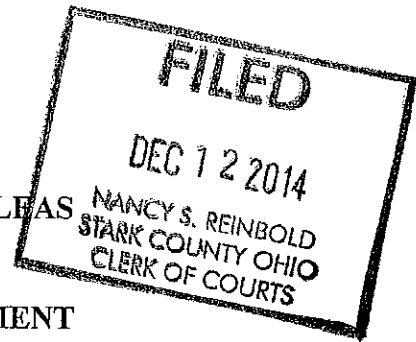

INDICTMENT

JUDGE:

Of the October Term, 12-11, 2014:

THE JURORS OF THE STARK COUNTY GRAND JURY of the State of Ohio on their oaths, in the name and authority of the State of Ohio, do find and present that:

**COUNT ONE**

On or between 09/13/2014 through 10/14/2014, in a continuing course of conduct in the County of Stark, the State of Ohio, the Defendants A) DAEMON FORD, aka "WA;" D) MICHAEL GREEN; F) JENNIFER JONES; G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; K) LATEEF MONTGOMERY; L) BRUCE

MOSELEY; O) JAMES ROSS, aka "SMOKEY;" Q) CHRISTIE JARVIS; did while associated with an enterprise, did conduct or participate in, either directly or indirectly, the affairs of the enterprise through a pattern of corrupt activity. The defendants engaged in, conspired to engage in, attempted to engage in, or coerced another to engage in violations of the law including, but not limited to, Trafficking in Heroin, Trafficking in Cocaine, Conspiracy to Trafficking in Heroin, Conspiracy to Trafficking in Cocaine, Complicity to Trafficking in Heroin, Complicity to Trafficking in Cocaine, Possession of Heroin, and Possession of Cocaine, as set out in the subsequent counts and incorporated as fully restated herein. At least one of the incidents of corrupt activity is a felony of the third degree or higher. This is in violation of 2923.32(A)(1) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to-wit: ENGAGING IN A PATTERN OF CORRUPT ACTIVITY, constitutes a felony of the First Degree.

On or between 09/13/2014 through 10/14/2014, in a continuing course of conduct in the County of Stark, and State of Ohio, A) DAEMON FORD, aka "WA;" B) JESSICA ACKERMAN; C) JENNIFER CARPENTER; D) MICHAEL GREEN; F) JENNIFER JONES; G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; K) LATEEF MONTGOMERY; L) BRUCE MOSELEY; M) TYLER MURRAY, N) TARA OLIS; O) JAMES ROSS, aka "SMOKEY;" P) KIM SMITH; and Q) CHRISTIE JARVIS, did, with purpose to commit or to promote or facilitate the commission of Trafficking in Heroin, and agree with another person or persons that one or more of them would engage in conduct that facilitates the commission of Trafficking in Heroin in an amount that equals or exceed 250 grams in weight, a violation of Sections 2925.03(A)(1)/(2)(C)(6)(g) of the Revised Code; contrary to the form of the statute (in violation of Section 2923.01(A)(2) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

This act, to-wit: CONSPIRACY TO TRAFFICKING IN HEROIN, constitutes a felony of the Second Degree.

The object of the conspiracy was to enrich the defendants through the unlawful trafficking of controlled substances at various locations in the County of Stark, and elsewhere.

In furtherance of the conspiracy and to effect its objects, the following overt acts, among others, were committed in the County of Stark, and elsewhere:

On or between 09/13/2014 through 10/14/2014, DAEMON FORD, aka "WA," did purchase approximately 318 grams of heroin for purposes of said heroin to be used and or resold.

On or about 8/30/2014, DAEMON FORD, aka "WA," moved his residence from 116 Fawcett Court, NW, Canton, Stark County, Ohio, to 12024 Georgetown Road, Paris Township, Stark County, Ohio, for the purpose of thwarting law enforcement investigation/surveillance of his drug trafficking activities.

On or between 09/13/2014 and 10/03/2014, JESSICA ACKERMAN arranged drug transactions for the purchase of 4.4 grams of heroin from DAEMON FORD, aka "WA," for \$451.00 for purposes of said heroin to be used and or resold.

On or between 09/13/2014 and 10/07/2014, JENNIFER CARPENTER arranged drug transactions for the purchase of 4.5 grams of heroin from DAEMON FORD, aka "WA," for \$630.00 for purposes of said heroin to be used and or resold.

On or between 09/14/2014 and 10/02/2014, MICHAEL GREEN arranged drug transactions for the purchase of 16 grams of heroin from DAEMON FORD, aka "WA," for \$1,600.00 for purposes of said heroin to be used and or resold.

On or between 09/14/2014 and 10/11/2014, JENNIFER JONES arranged drug transactions for the purchase of 2.9 grams of heroin from DAEMON FORD, aka "WA," for \$290.00.

On or between 09/14/2014 and 10/11/2014, JENNIFER JONES arranged drug transactions for the purchase of heroin from DAEMON FORD, aka "WA," in exchange for the value of stolen items.

On or between 09/13/2014 and 10/10/2014, JACQUELINE LONGOBARDI arranged drug transactions for the purchase of 18.9 grams of heroin from DAEMON FORD, aka "WA," for \$1,890.00 for purposes of said heroin to be used and or resold.

On or about 9/16/2014, SHELBY MARLATT arranged a drug transaction for an amount of heroin to be delivered to JENNIFER JONES by SHELBY MARLATT from DAEMON FORD, aka "WA."

On or between 09/13/2014 and 10/10/2014, SHELBY MARLATT and ERIK MARLATT arranged drug transactions for the purchase of 8.6 grams of heroin from DAEMON FORD, aka "WA," for \$1,000.00 for purposes of said heroin to be used and or resold.

On or between 09/16/2014 and 10/09/2014, CARLTON MILLER arranged drug transactions for the purchase of 81 grams of heroin from DAEMON FORD, aka "WA," for \$7,455.00 for purposes of said heroin to be used and or resold.

On or between 09/16/2014 and 10/10/2014, LATEEF MONTGOMERY arranged drug transactions for the purchase of 13.5 grams of heroin from DAEMON FORD, aka "WA," for \$1,350.00 for purposes of said heroin to be used and or resold.

On or between 09/14/2014 and 10/10/2014, BRUCE MOSELEY arranged drug transactions for the purchase of 84 grams of heroin from DAEMON FORD, aka "WA," for \$8,400.00 for purposes of said heroin to be used and or resold.

On or between 09/18/2014 and 9/26/2014, TYLER MURRAY arranged drug transactions for the purchase of 2 grams of heroin from DAEMON FORD, aka "WA," for \$200.00 for purposes of said heroin to be used and or resold.

On or between 09/23/2014 and 10/04/2014, TARA OLIS arranged drug transactions for the purchase of 1.7 grams of heroin from DAEMON FORD, aka "WA," for \$170.00 for purposes of said heroin to be used and or resold.

On or about 9/26/2014, JAMES ROSS, aka "SMOKEY," drove DAEMON FORD, aka "WA," and LATEEF MONTGOMERY to Detroit, Michigan from Stark County, Ohio, for the purpose

of purchasing approximately 170 grams of heroin, and transported the heroin back to Stark County, Ohio for purposes of said heroin to be used and or resold.

On or about 10/14/2014, JAMES ROSS, aka "SMOKEY," drove DAEMON FORD, aka "WA," and MICHAEL GREEN to an unknown location in the State of New York for the purpose of transporting at least 19 grams of heroin from the unknown location in the State of New York, to Stark County, Ohio, for the purpose of said heroin to be used and or resold.

On or between 10/06/2014 and 10/11/2014, KIM SMITH arranged drug transactions for the purchase of 1.9 grams of heroin from DAEMON FORD, aka "WA," for \$210.00 for purposes of said heroin to be used and or resold.

On or between 09/13/2014 and 10/05/2014, CHRISTIE JARVIS arranged drug transactions for the purchase of 12.7 grams of heroin from DAEMON FORD, aka "WA," for \$1,480.00 for purposes of said heroin to be used and or resold.

**SPECIFICATION ONE OF COUNT TWO:** The Grand Jurors further find and specify that A) DAEMON FORD, aka "WA;" B) JESSICA ACKERMAN; C) JENNIFER CARPENTER; D) MICHAEL GREEN; F) JENNIFER JONES; G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; K) LATEEF MONTGOMERY; L) BRUCE MOSELEY ; M) TYLER MURRAY, N) TARA OLIS; O) JAMES ROSS, aka "SMOKEY;" P) KIM SMITH; and Q) CHRISTIE JARVIS, are major drug offenders as set forth in Section 2929.01(X) in that they are convicted of or plead guilty to Conspiracy to Trafficking in Heroin, of at least 250 grams of heroin, a Schedule I controlled substance, in violation of 2923.01(A)(2) and 2925.03(A)/(2)(1)(C)(6), contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

### **COUNT THREE**

On or between 09/20/2014 through 10/11/2014, in a continuing course of conduct in the County of Stark, and State of Ohio, A) DAEMON FORD, AKA "WA," aka "WA;" G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; and K) LATEEF MONTGOMERY; and M) TYLER MURRAY, did, with purpose to commit or to promote or facilitate the commission of Trafficking in Cocaine, and agree with another person or persons that one or more of them would engage in conduct that facilitates the commission of Trafficking in Cocaine in an amount that exceeds 20 grams but is less than 27 grams, a violation of Section 2925.03(A)(1)(C)(4) of the Revised Code; contrary to the form of the statute (in violation of Section 2923.01(A)(2) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

This act, to-wit: CONSPIRACY TO TRAFFICKING IN COCAINE, constitutes a felony of the Third Degree.

The object of the conspiracy was to enrich the defendants through the unlawful trafficking of controlled substances at various locations in the County of Stark, and elsewhere.

In furtherance of the conspiracy and to effect its objects, the following overt acts, among others, were committed in the County of Stark, and elsewhere:

On or between 09/20/2014 through 10/11/2014, DAEMON FORD, aka "WA," did purchase approximately 23 grams of cocaine for purposes of said cocaine to be used and or resold.

On or about 08/30/2014, DAEMON FORD, aka "WA," moved his residence from 116 Fawcett Court, NW, Canton, Stark County, Ohio, to 12024 Georgetown Road, Paris Township, Stark County, Ohio, for the purpose of thwarting law enforcement investigation/surveillance of his drug trafficking activities.

On or about 10/07/2014, JACQUELINE LONGOBARDI arranged a drug transaction for the purchase of 3.5 grams of cocaine from DAEMON FORD, aka "WA," for \$150.00 for purposes of said cocaine to be used and or resold.

On or between 10/10/2014 and 10/11/2014, SHELBY MARLATT and ERIK MARLATT arranged drug transactions for the purchase of .32 grams of cocaine from DAEMON FORD, aka "WA," for \$40.00 for purposes of said cocaine to be used and or resold.

On or between 9/20/2014 and 10/02/2014, CARLTON MILLER arranged drug transactions for the purchase of 15.32 grams of cocaine from DAEMON FORD, aka "WA," for \$1,155.00 for purposes of said cocaine to be used and or resold.

On or about 10/09/2014, LATEEF MONTGOMERY arranged a drug transaction for the purchase of 1.3 grams of cocaine from DAEMON FORD, aka "WA," for \$100.00 for purposes of said cocaine to be used and or resold.

On or between 9/20/2014 and 10/03/2014, TYLER MURRAY arranged drug transactions for the purchase of 3.5 grams of cocaine from DAEMON FORD, aka "WA," for \$200.00 for purposes of said cocaine to be used and or resold.

#### **COUNT FOUR**

On or between 09/13/2014 through 10/14/2014, in the County of Stark, and State of Ohio, A) DAEMON FORD, aka "WA;" B) JESSICA ACKERMAN; C) JENNIFER CARPENTER; D) MICHAEL GREEN; E) MELISSA MARTENY, aka "HOLLYWOOD;" F) JENNIFER JONES; G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; K) LATEEF MONTGOMERY; L) BRUCE MOSELEY ; M) TYLER MURRAY, N) TARA OLIS; O) JAMES ROSS, aka "SMOKEY;" P) KIM SMITH; and Q) CHRISTIE JARVIS; did knowingly, acting with the kind of culpability required for the commission of an offense, aid or abet another in committing Trafficking in Heroin in an amount exceeding 250 grams, a violation of Section 2925.03(A)(1)/(2)(C)(6) of the Revised Code, (in violation of Section 2923.03 of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

This act, to-wit: COMPLICITY TO TRAFFICKING IN HEROIN, constitutes a felony of the First Degree.

**SPECIFICATION ONE OF COUNT FOUR:** The Grand Jurors further find and specify that, A) DAEMON FORD, AKA "WA," aka "WA;" B) JESSICA ACKERMAN; C) JENNIFER CARPENTER; D) MICHAEL GREEN; E) MELISSA MARTENY, aka "HOLLYWOOD;" F) JENNIFER JONES; G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; K) LATEEF MONTGOMERY; L) BRUCE MOSELEY ; M) TYLER MURRAY, N) TARA OLIS; O) JAMES ROSS, aka "SMOKEY;" P) KIM SMITH; and Q) CHRISTIE JARVIS; are major drug offenders as set forth in Section 2929.01(X) in that they are convicted of or plead guilty to Complicity to Trafficking in Heroin, of at least 250 grams of heroin, a Schedule I controlled substance, in violation of 2923.01(A)(2) and 2925.03(A)(1)/(2)(C)(6), contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

**COUNT FIVE**

On or between 09/20/2014 through 10/11/2014, in the County of Stark, and State of Ohio, A) DAEMON FORD, aka "WA;" G) JACQUELINE LONGOBARDI; H) SHELBY MARLATT; I) ERIK MARLATT; J) CARLTON MILLER; and K) LATEEF MONTGOMERY; and M) TYLER MURRAY, did knowingly, acting with the kind of culpability required for the commission of an offense, aid or abet another in committing Trafficking in Cocaine in an amount that equals or exceeds 20 grams but is less than 27 grams, a violation of Section 2925.03(A)(1)(C)(4), of the Revised Code, in such case made and provided, and against the peace and dignity of the State of Ohio.

This act, to-wit: COMPLICITY TO TRAFFICKING IN COCAINE, constitutes a felony of the Second Degree.

**COUNT SIX**

On or Between 9/12/2014 through 9/26/2014, in the County of Stark, and State of Ohio, one A) DAEMON FORD, aka "WA," did knowingly, sell or offer to sell, heroin, a Schedule I controlled substance, in an amount that equals or exceeds 50 grams, but is less than 250 grams. This is in violation of Section 2925.03(A)(1)(C)(6) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: TRAFFICKING IN HEROIN, constitutes a felony of the First Degree.

**COUNT SEVEN**

On or Between 9/26/2014 through 10/11/2014, in the County of Stark, and State of Ohio, one A) DAEMON FORD, aka "WA," did knowingly, sell or offer to sell, heroin, a Schedule I controlled substance, in an amount that equals or exceeds 250 grams. This is in violation of Section 2925.03(A)(1)(C)(6) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: TRAFFICKING IN HEROIN, constitutes a felony of the First Degree.

**SPECIFICATION ONE OF COUNT SEVEN:** The Grand Jurors further find and specify that, A) DAEMON FORD, aka “WA;” is a major drug offender as set forth in Section 2929.01(X) in that he is convicted of or plead guilty to Trafficking in Heroin, of at least 250 grams of heroin, a Schedule I controlled substance, in violation of 2925.03(A)(1)(C)(6), contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

### **COUNT EIGHT**

On or about 9/26/2014, in the County of Stark, and State of Ohio, A) DAEMON FORD, aka “WA;”, O) JAMES ROSS, aka “SMOKEY,” and K) LATEEF MONTGOMERY did knowingly prepare for shipment, ship, transport, deliver, prepare for distribution, or distribute a drug, Heroin, a Schedule I controlled substance, when A) DAEMON FORD, aka “WA;” O) JAMES ROSS, aka “SMOKEY,” and K) LATEEF MONTGOMERY knew or had reasonable cause to believe that the controlled substance is intended for resale by A) DAEMON FORD, aka “WA;” or another person, in an amount that equals or exceeds 50 grams but is less than 250 grams in weight, in violation of Section 2925.03(A)(2)(C)(6) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: TRAFFICKING IN HEROIN, constitutes a felony of the First Degree.

**FORFEITURE SPECIFICATION ONE OF COUNT EIGHT:** The Grand Jurors further find and specify that Defendant K) LATEEF MONTGOMERY’s right, title, or interest in the following items shall be subject to forfeiture to the State of Ohio, the property having been obtained through the commission of illegal felony drug abuse activity, to-wit: Smith & Wesson .40 caliber handgun S/N RBD4353; 12 gauge Shotgun with camouflage finish S/N R963275; Mossberg 70Z Plinkster .22 caliber Rifle S/N ECF104328; Mossberg 12 gauge pump action shotgun.

### **COUNT NINE**

Between on or about 10/13/2014 and 10/14/2014, in the County of Stark, and State of Ohio, A) DAEMON FORD, aka “WA;” D) MICHAEL GREEN, and O) JAMES ROSS, aka “SMOKEY,” did knowingly prepare for shipment, ship, transport, deliver, prepare for distribution, or distribute a drug, Heroin, a Schedule I controlled substance, when DAEMON FORD, aka “WA;”, D) MICHAEL GREEN, and O) JAMES ROSS, aka “SMOKEY,” knew or had reasonable cause to believe that the controlled substance was intended for resale by DAEMON FORD, aka “WA;” or another person, in an amount that equals or exceeds 10 grams but is less than 50 grams in weight, in violation of Section 2925.03(A)(2)(C)(6) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: TRAFFICKING IN HEROIN, constitutes a felony of the Second Degree.



**FORFEITURE SPECIFICATION ONE OF COUNT NINE:** The Grand Jurors further find and specify that Defendant A) DAEMON FORD, aka "WA's," right, title, or interest in the following items shall be subject to forfeiture to the State of Ohio, the property having been obtained through the commission of illegal felony drug abuse activity, to-wit: Smith and Wesson 40 caliber semi-automatic pistol, Model# SD40VE S/N HEE8383; and the following cell phones: White Apple I-phone 4s Mod# A1387, LG272 S/N 3116YRN0422758, Kyocera Mod# C5133, Blackberry 8330 S/N ESN07616701511, Black Apple I-phone mod# A1349.

**FORFEITURE SPECIFICATION TWO OF COUNT NINE:** The Grand Jurors further find and specify that Defendant O) JAMES ROSS, aka "SMOKEY's" right, title, or interest in the following items shall be subject to forfeiture to the State of Ohio, the property having been obtained through the commission of illegal felony drug abuse activity, to-wit: Hi Point C9 9mm S/N P1653378; Hi Point C9 9mm S/N P005065; Kurz .380 caliber S/N M13386.

**FORFEITURE SPECIFICATION THREE OF COUNT NINE:** The Grand Jurors further find and specify that Defendant D) MICHAEL GREEN's right, title, or interest in the following items shall be subject to forfeiture to the State of Ohio, the property having been obtained through the commission of illegal felony drug abuse activity, to-wit: Walther PK 380 S/N WB018549; and the following cell phones: Samsung S/N R21F80GJFET, Red HTC Beats Audio Cell phone, White/Gold I-phone IMEI# 352002063147177, Grey LC Cell IMEI # 013948-00-309915-2.

### **COUNT TEN**

On or about 10/10/2014, in the County of Stark as a continuing course of conduct through Guernsey County Ohio and other locations, and the State of Ohio, A) DAEMON FORD, AKA "WA," and C) JENNIFER CARPENTER, did knowingly prepare for shipment, ship, transport, deliver, prepare for distribution, or distribute a drug, Heroin, a Schedule I controlled substance, when A) DAEMON FORD, aka "WA," and C) JENNIFER CARPENTER knew or had reasonable cause to believe that the controlled substance was intended for resale by A) DAEMON FORD, aka "WA," or another person, in an amount that equals or exceeds 10 grams but is less than 50 grams in weight, in violation of Section 2925.03(A)(2)(C)(6) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: TRAFFICKING IN HEROIN, constitutes a felony of the Second Degree.

### **COUNT ELEVEN**

Between on or about 9/25/2014, in the County of Stark, and State of Ohio, E) MELISSA MARTENY, aka "HOLLYWOOD," did knowingly attempt to prepare for shipment, ship, transport, deliver, prepare for distribution, or distribute a drug, Heroin, a Schedule I controlled substance, when E) MELISSA MARTENY, aka "HOLLYWOOD," knew or had reasonable cause to believe that the controlled substance is intended for resale by A) DAEMON FORD, aka

“WA,” or another person, in an amount that equals or exceeds 50 grams but is less than 250 grams in weight, in violation of Section 2925.03(A)(2)(C)(6) and 2923.02(A) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

This act, to wit: ATTEMPTED TRAFFICKING IN HEROIN, constitutes a felony of the Second Degree.

#### **COUNT TWELVE**
