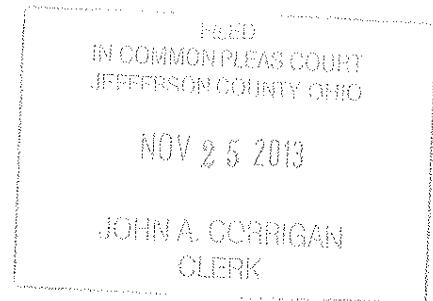

**INDICTMENT**

COURT OF COMMON PLEAS

In the Court of Common Pleas, Jefferson County, Ohio, of the Special Grand Jury term in the year Two Thousand and THIRTEEN, (convened April 15, 2013)

COUNT ONE

(TAMPERING WITH EVIDENCE)

THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 5, 2012 to November 19, 2013, at Jefferson County, Ohio, Michael McVey did, knowing that an official proceeding or investigation was in progress, or was about to be or likely to be instituted, did alter, destroy, conceal, or remove any record, document, or thing, with purpose to impair its value or availability as evidence in such proceeding or investigation and / or did make, present, or use any record, document, or thing, knowing it to be false and with purpose to mislead a public official who was or may have been engaged in such proceeding or investigation, or with purpose to corrupt the outcome of any such proceeding or investigation, in violation of Section 2921.12(A)(1) & (2) of the Revised Code, and against the peace and dignity of the State of Ohio, a Felony of the Third Degree.

COUNT TWO

(OBSTRUCTING JUSTICE)

THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 5, 2012 to November 19, 2013, at Jefferson County, Ohio, Michael McVey did with purpose to hinder the discovery, apprehension, prosecution, conviction, or punishment of another for crime or to assist another to benefit from the commission of a crime, did destroy or conceal physical evidence of the crime or act, or did induce a person to withhold testimony or information or to elude legal process summoning the person to testify or supply evidence, in violation of Section 2921.32(A)(4) of the Revised Code, and against the peace and dignity of the State of Ohio, a Felony of the Fifth Degree.

**COUNT THREE**  
**(OBSTRUCTING JUSTICE)**

THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 5, 2012 to November 19, 2013, at Jefferson County, Ohio, Michael McVey did with purpose to hinder the discovery, apprehension, prosecution, conviction, or punishment of another for crime or to assist another to benefit from the commission of a crime, did communicate false information to a person, in violation of Section 2921.32(A)(5) of the Revised Code, and against the peace and dignity of the State of Ohio, a Felony of the Fifth Degree.

**COUNT FOUR**  
**(FALSIFICATION)**

THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 5, 2012 - , at Jefferson County, Ohio, Michael McVey did knowingly make a false statement and the statement was made with purpose to mislead a public official in performing the public official's official function, in violation of Section 2921.13 (A)(3) of the Revised Code, and against the peace and dignity of the State of Ohio, a Misdemeanor of the First Degree.

**COUNT FIVE**  
**(OBSTRUCTING OFFICIAL BUSINESS)**


THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 5, 2012 to November 19, 2013, at Jefferson County, Ohio, Michael McVey without privilege to do so and with purpose to prevent, obstruct, or delay the performance by a public official of any authorized act within the public official's official capacity, did commit an act that hampered or impeded a public official in the performance of the public official's lawful duties, in violation of Section 2921.31(A) of the Revised Code, and against the peace and dignity of the State of Ohio, a Misdemeanor of the Second Degree.

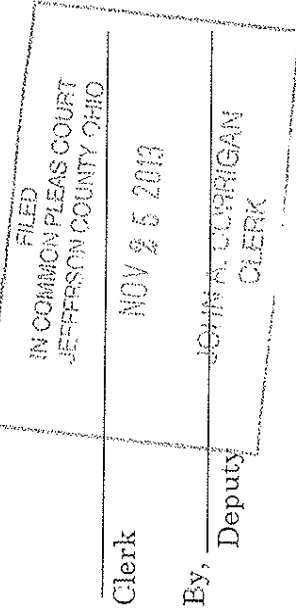
