3. Compulsory retirement age is seventy years.
4. Board is without authority to refuse contributions from any employe member under seventy years of age who failed to file written application for continuance in service 770

AGE LIMITATION—

1. Retirement system, public employes—Employe member sixty-nine years of age or over—May be continued in public service under section 486-59 G. C.

AGENT—PAYING—

1. Bond issuing authority—Paying agent designated to redeem bonds and interest coupons—Agent of bond issuing authority and not of bond holder who presents bonds or coupons for payment.
2. Paying agents may not deduct service charge from full face amount of bonds or coupons at time of presentation for payment..... 659

AGENT—SALESMAN—

Page

1. Eyeglasses—Optical firm located in foreign state—Where advertising sent to prospective purchasers in Ohio—Offer to send by mail, machine containing lenses to determine prescription needed for eyeglasses. Optical firm is practicing optometry in Ohio.
2. If machine purchased from unlicensed firm located outside of Ohio, firm authorized to solicit other business in state, compensation one dollar per order, the individual becomes agent of optical firm—Unlicensed optical firm subject to prosecution in county where offense committed 579

AGRICULTURAL SOCIETY—COUNTY—

- Management and control of county fair grounds—Title vested in county—May contract to erect building on county fair grounds—Public advertising for competitive bids not required—Section 9887-1 G. C. 678
- Powers and duties of county commissioners—Any building erected pursuant to section 9887 G. C. must be placed under control and management of duly organized agricultural society 326

AID FOR AGED—

County Commissioners :

1. May condemn land, pay damages, lay out, grade and surface new public road—Road may be turned over to township trustees for maintenance and repair—Road must be within limits of township.
2. Commissioners not authorized by law to establish special fund for maintenance and use of county infirmary—Moneys received for board from inmates of home—Recipients of aid for aged 95

Secret—State communication—Division of Aid for Aged—May not permit Industrial Commission to examine file of old age recipient—Purpose to determine if medical date consistent with that placed on file for workmen's compensation—Section 1359-24a G. AIRPORT—PROPERTY—

Ohio University—Not within power of "The President and Trustees of the Ohio University" to enter into contract or to lease property belonging to university to private corporation engaged in enterprise for profit, while property presently used to carry on educational program—Enterprise of private corporation not incidental to maintenance of university..... 286

AKRON MUNICIPAL WATERWORKS—

Page

- 1. Municipal waterworks—Chief administrator, city of Akron—Authority to expend funds to study ways and means to improve waterworks service—Educational features—To induce employes to attend meetings after working hours, administrator may provide refreshments and pay for them out of waterworks funds.

ALCOHOLICS—CHRONIC—

- 4. Private institutions established to care for chronic alcoholics—May be considered institutions to care for the mentally ill 250

ALIEN LAND ACT OF WASHINGTON—

- 1. Foreign nation—In absence of treaty with United States—May not hold title to real estate located in Ohio without express consent of state.
- 2. International law—Principles of reciprocity and comity embodied in international law not available to a state of United States in absence of treaty between federal government and a foreign nation 621

AMENDED ASSESSMENT CERTIFICATE—

- 1. Tax—Penalty not required to be added by sections 5377 or 5394 G. C.—Where amended preliminary assessment certificate is issued and payment of additional tax is required by amended certificate.

ANNEXATION—TERRITORY—

Annexation—Submission of proposition to voters—Village may not lawfully annex all contiguous territory surrounding but not including property where liquor, beer and wine permits are effective—Isolation of territory from physical contact with township lands—Village may not in ordinance for annexation provide all property located within or along territory to be annexed be excluded from ordinance—Territory presently used as established place to sell liquor, beer and wine under permits issued by board of liquor control 253

ANNEXATION TRANSCRIPT—PETITION—PLAT—

Before city council for final action—Petition on table for indefinite period—County commissioners can rescind resolution of approval and may request city council to recall tabled petition and reject proposed annexation—Section 3550 G. C. 552

ANNEXED TERRITORY TO MUNICIPALITY—

1. Territory annexed to municipality—Vote by electors of unincorporated area of township—Application made by adjacent municipality to annex territory within township—Provisions of section 3561-6 G. C. do not apply when annexation is upon application of resident freeholders of territory.
2. Petitioners have the right to amend petition requesting annexation of territory to municipality subject to permission of county commissioners to amend—Section 3521 G. C. 404

ANNEXED TERRITORY—

1. Township lines—Village by resolution requested county commissioners to reduce township lines of township—Lines to be co-extensive and coterminous with village lines—Commissioners to grant request must either annex remaining territory of original township or contiguous township or townships or create remaining territory into new townships—May or may not include territory annexed from contiguous township or townships.

3. Where two statutes of the General Code are in direct conflict, statute with most recent effective date is controlling 72

APPARATUS—FIRE DEPARTMENT—

Fire department—Township trustees—Fire district created—Trustees may enter into contract with volunteer fire department for fire protection for entire township exclusive of municipal corporation—Volunteer fire department owns its own apparatus—Section 3298-54 G. C. 439

APPEAL—

Public Assistance Board of Appeals—Without authority or jurisdiction to review decisions of State Department of Public Welfare—In re applications for aid to dependent children—Where appeal filed by county administration to Public Assistance Board of Appeals 134

APPLICATION—BARBER'S EXAMINATION—

Barber examiners, state board of—May not accept application for barber examination from applicant who never held barber's license in Ohio or any other state—No exception where applicant can produce evidence of two years' of barbering experience prior to enforcement of Ohio barber law, September, 1933 105

APPLICATION FOR RETIREMENT—WRITTEN—

1. Retirement board, public employes, chairman—Written application for retirement not required to be filed by members under age of seventy years—Section 486-59 G. C.
2. Written application required of members subject to retirement at age of seventy years—Necessary for continuance in service.
3. Compulsory retirement age is seventy years.
4. Board is without authority to refuse contributions from any employe member under seventy years of age who failed to file written application for continuance in service 770

APPOINTEE—

1. Controlling Board—Practice of General Assembly, each biennium, to establish board and authorize board to appoint comptroller—Period during which liabilities may be incurred under general appropriation act—Amended House Bill 654, 98 General Assembly—Position not a continuing public office—No hold over after expiration of term until successor elected or appointed and qualified—Section 8 G. ARCHITECTS—ENGINEERS—

1. Metropolitan Housing Authority—Can not use rental income to employ engineers to survey land it owns—In preparation to hiring architects—Preliminary studies or surveys.
2. Income from housing units can not be used by Authority to pay flat fee per month to planning commission to finance public housing portion of city's over-all planning program.
3. Authority can not use rental income to employ engineer, clerks or other types of employes for assignment to work with city planning commission as Authority's contribution towards public housing portion of city's over-all plan 961

ARMY AND NAVY—

1. Hospital—Board of trustees of county memorial hospital—Not required by law to grant discounts to soldiers, sailors and marines—May in exercise of discretion do so.
2. Soldiers, sailors and marines—Words include all former members of army and navy, irrespective as to term of service—Section 3137 G. C.
3. Term "of the county" refers to residents of county at time of admission to hospital 515

ARREST—

1. Arrest actually made by state highway patrolman—Magistrate not authorized to issue warrant to chief of police and tax fees and costs in favor of chief of police where services not actually performed—Fees and costs when collected "public money" as defined in section 286 G. C.
 2. Fees and costs taxed for services not actually performed—Bureau of Inspection and Supervision of Public Offices may make findings for recovery of such fees in favor of "Defendant's Trust Fund"—Moneys to be returned to respective persons from whom they were erroneously collected—Section 274 et seq., G. C. 236
- Patrol, state highway—Without authority to arrest driver of United States truck—Without possession of operator's license required of motor vehicle operators in Ohio 301

ATHENS COUNTY—

Cemetery:

1. Contributions—Section 8623-119 G. C. grants authority to corporation, including insurance companies, stock and mutual, to contribute corporate funds to projects "conducive to public welfare"—Contributions must be to aid company growth or development, charitable, philanthropic or benevolent instrumentalities—Must in judgment of directors of corporation contribute to protection or advancement of its interests.
2. Shareholders of corporation—Meeting—When entitled to notice of expenditures.

WITNESS FEES—

1. Physician employed at Lima State Hospital—Called as witness in criminal case—Not required in discharge of official duties to be present as witness at the hearing—Entitled to same witness fee as any private person called as witness.
2. When such physician is called as witness in criminal case and his presence is required in discharge of official duties, he is not entitled to witness fees—Section 13451-20 G. C.
3. When as stated in paragraph 1 of syllabus a physician is entitled to a witness fee he may retain the fee as does any other witness..... 393

WORLD WAR II COMPENSATION FUND—

Page

1. Employe, state, presently employed—Formerly employed by World War II compensation fund, not entitled to prior service credit under House Bill 484, 96 General Assembly for time employed by World War II compensation fund.
2. Present state employe formerly employed by World War II compensation fund not entitled to credit accumulated for sick leave while employed by World War II compensation fund—Section 486-17c G. C. 504

“WRITE-IN” CANDIDATE—

1. Ballot—Name written on ballot at general election—May be counted as vote for person whose name is so written for office indicated on ballot.
2. Section 4785-69 G. C. prohibits a person who seeks a party nomination for office or position at primary election to become candidate at following election for same office by petition—Such person not prohibited from becoming a “write-in” candidate.
3. Board of elections—May consider only one factor as to the count of a “write-in” vote—Is it possible to determine the voter’s choice? 916

X-RAY TECHNICIAN—

- Appointed by county coroner—Section 2855-17 G. C.—Not entitled to compensation for services under section 2855-18 G. C. 695

ZONING ORDINANCE—

1. Municipality—Zoning ordinance—Can not be construed to apply to a county vested with right of eminent domain—Use of lots for public purposes—Lots not acquired by appropriation proceedings—Acquired by purchase.
2. Use of a lot by county—Erection, steel storage building—Use of county engineer—Public purpose. 728
