When a firearm is stolen, it typically ends up on the street — usually in criminal hands. Often, law enforcement agencies know that a weapon has been stolen, but they lack information — such as a serial number — to be able to prove it.

Your insurance company will want that information, too, before it pays a claim.

This booklet serves as a practical tool for gun owners, one in which you can record the type, serial number, manufacturer, model and caliber of each firearm you own.

Kept separately and securely from your firearms, the private inventory helps to preserve details about these heirlooms as they are passed from generation to generation — details that can enhance the value of firearms as collector's items.

In addition, this inventory helps to ensure that firearms, if lost or stolen, can be quickly and accurately reported to law enforcement and to your insurer.

Supporters of the Second Amendment will want to keep this private inventory to help prevent stolen firearms from landing in criminal hands. Join me in filling one out as soon as possible!
