Gentlemen:

In accordance with Ohio Revised Code Section 109.731(D), I am pleased to present the 2007 report on Ohio's concealed handgun law. This information is provided to the Ohio Peace Officer Training Commission by Ohio's county sheriffs.

Ohio law requires the Ohio Peace Officer Training Commission to report, not later than the first day of April, the number of licenses to carry a concealed handgun that were issued, renewed, suspended, revoked, and denied in the previous calendar year, the number of applications for those licenses for which processing was suspended, and the number of temporary emergency licenses to carry a concealed handgun that were issued, suspended, revoked, or denied.

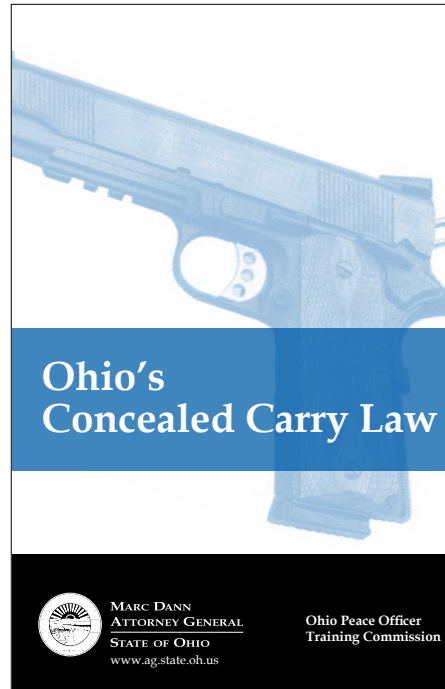

Ohio's law to allow citizens to carry concealed handguns went into effect on April 8, 2004. The law allows citizens with proper firearms safety training to apply with their county sheriff, or a sheriff of an adjacent county, for a license to carry a concealed handgun.

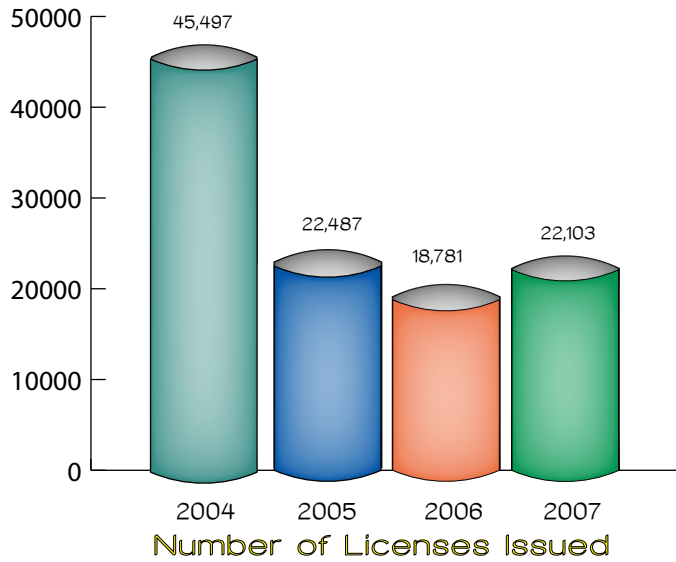
Persons who apply for a license are required to undergo a criminal history background check to ensure that they are not prohibited by law from carrying a concealed handgun. For persons who have lived in Ohio for five years or more, the sheriff submits the applicant's fingerprints electronically to the Ohio Bureau of Criminal Identification and Investigation for an in-state criminal background check. Applicants who have lived in Ohio fewer than five years are required to undergo a national check through the Federal Bureau of Investigation.

Ohio law requires county sheriffs to provide statistical information about the licenses they issue to the Ohio Peace Officer Training Commission. The Commission, in turn, is required by Ohio Revised Code Chapter 109.731 to compile those statistics and report them to the Governor and the leadership of the General Assembly each year.



All applicants for a concealed handgun license are required to take handgun safety training and to read the summary of the law published by the Attorney General's Office. Copies of the booklet are provided at no cost by contacting Attorney General Dann's Help Center at 1-877-AG4OHIO.

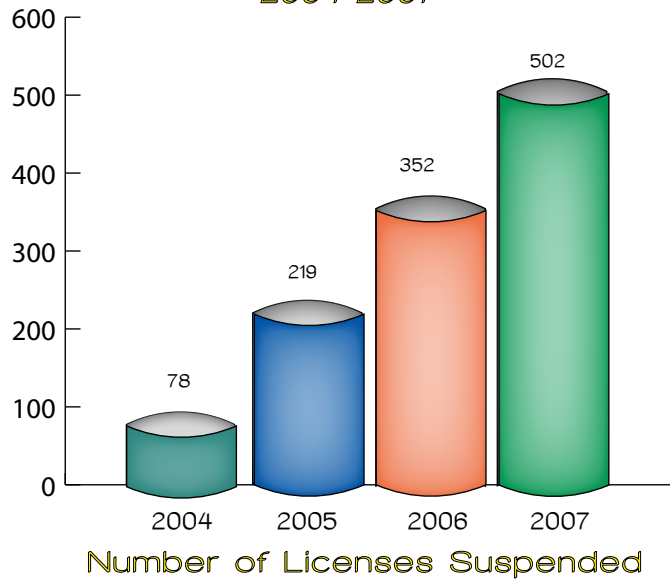

In calendar year 2007—the third full year of Ohio’s Concealed Handgun Law, Ohio sheriffs issued 22,103 licenses, an increase of nearly 18 percent from the previous year, analogous to 2005, and a drop of approximately 51 percent compared to the number of licenses issued in the law’s inaugural year, between April and December 2004.

For calendar year 2006—the second full year the law was in effect—Ohio sheriffs issued 18,781 regular licenses to carry concealed handguns.

This year, the sheriffs issued 66 temporary emergency licenses, which allow a person who submits evidence of imminent danger to receive a non-renewable 90-day license to carry a concealed handgun. Since the law went into effect in 2004, sheriffs have issued 109,001 regular and temporary emergency licenses to Ohioans.

Suspended 2004-2007**

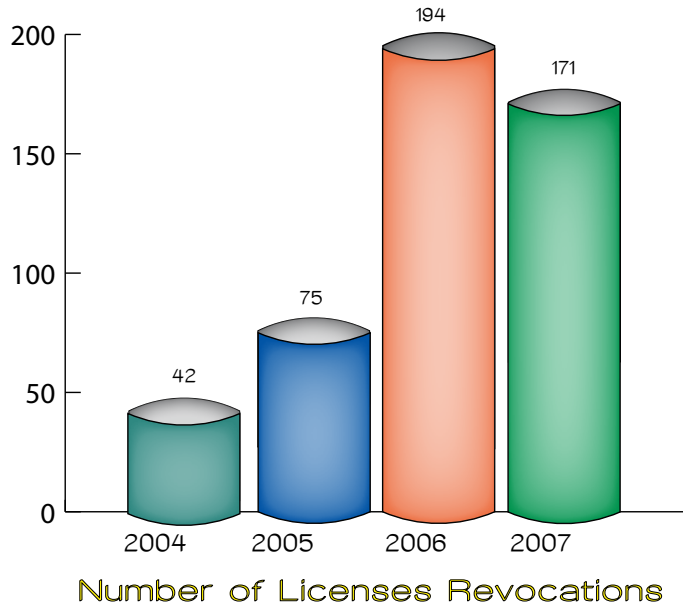

Under ORC 2923.128, sheriffs must immediately suspend a concealed handgun license upon notification that the licensee has been arrested or charged with certain offenses, or if the licensee is the subject of a protection order issued by a court.

In 2007, sheriffs suspended 502 regular licenses, compared to 352 in 2006. In 2005, sheriffs suspended 219 concealed handgun licenses.

It is important to note that some of these licenses may have been issued in previous years. Sheriffs are not required to report the details surrounding a suspension.

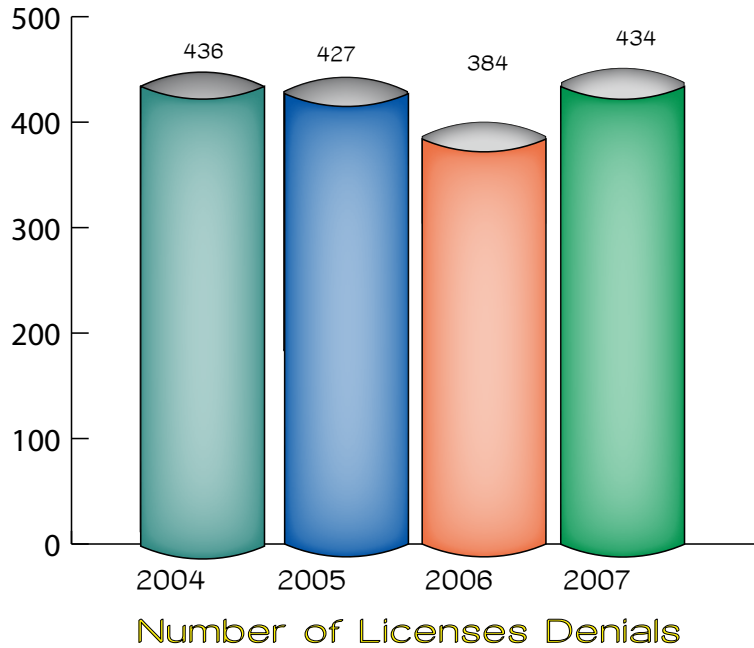
That same section of the Ohio Revised Code also requires sheriffs to revoke the license of any person who no longer meets the eligibility requirements to carry a concealed handgun.

In 2007, 171 regular licenses were revoked because the licensee was no longer eligible to hold a concealed carry license.

The reasons for revocation vary. It could be due to a move out of state or the death of the licensee, or the licensee no longer wanting to hold the license. Revocation may also be a result of a disqualifying criminal conviction, to becoming subject to the law's restrictions on mentally ill persons or persons considered drug or alcohol dependent. Sheriffs are not required by the law to report the specific reason for the revocation to the Peace Officer Training Commission. Again, licenses that were revoked in 2007 may have been issued in 2006 or 2005.

In 2006, Ohio sheriffs revoked a total of 194 licenses and in 2005, that number was 75.

The law requires that sheriffs shall deny an application by any person who fails to meet the eligibility criteria specified in R.C. 2923.125 for regular licenses, or R.C. 2923.1213 for temporary emergency licenses.

For calendar year 2007, sheriffs denied 434 applications for regular licenses and 3 applications for temporary emergency licenses.

In 2006, sheriffs denied 384 applications for regular licenses and 4 applications for temporary emergency licenses.

As April 1, 2008, Ohio has reciprocity agreements in place with these states

The law requires the Ohio Attorney General to craft reciprocity agreements with other states to allow Ohioans with permits to carry weapons in those jurisdictions and for those states' citizens to carry weapons in Ohio.

These agreements require an analysis of those other laws to ensure they meet the requirements of Ohio's concealed handgun law and vice versa (RC 109.69).
