Dear Colleagues:

Every year my office assists, through the Ohio Victims of Crime Compensation Fund, thousands of Ohioans who have been affected by violent crime, and this year was no exception.

Ohio Revised Code (ORC) Section 2743.69 requires my office to prepare an annual update on the Ohio Victims of Crime Compensation Fund. This report, which covers the period from July 1, 2014 through June 30, 2015, fulfills that mandate and also details my office's other efforts to ease the burden crime victims face through no fault of their own.

Through the compensation fund, my office helps victims and their families recover certain costs incurred as a result of the crime, such as medical expenses, counseling, and lost wages. Since 1976, the compensation fund has distributed more than \$351 million to victims of violent crime in Ohio. During fiscal year 2015, my office processed 2,948 requests for compensation and paid out an average of \$2,530 per claim.

We received an unprecedented increase in the amount of grant funding that we receive from the federal government under the Victim of Crime Act. As a result, we created the "Expanding Services, Empowering Victims Initiative." These funds and this initiative will allow victim service agencies across the state to improve upon and expand the services that they provide to victims of crime. It also allows us to fund new and innovative programs to empower victims to become survivors. During fiscal year 2015, over \$52 million in grants were awarded to 300 community agencies throughout all Ohio counties. These grants ensure that all victims have access to much needed services. In fiscal year 2015, the Crime Victim Services staff trained over 4,000 people on topics that included victim compensation, elder abuse, domestic violence, sexual assault, and child abuse. And our Two Days in May Conference on Victim Assistance – one of the largest gatherings of its kind in the nation – drew over 1,100 victim advocates and criminal justice professionals who took advantage of insightful presentations and useful workshops.

As the pages of this report indicate, my office is committed to assisting crime victims as well as the advocates who work on their behalf. Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred from the Court of Claims of Ohio to the Ohio Attorney General's Office on July 1, 2000, and other benefits have been added through the years. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section administers state and federal grants to support communities' victim assistance programs; provides education and training for victims, victim advocates, and the general public; and ensures that other resources are in place to ease crime victims' challenges.

Grants Unit

The Grants Unit of the Crime Victim Services Section administers state and federal grants to victim service providers. These State Victims Assistance Act (SVAA) and federal Victims of Crime Act (VOCA) grants are made up of funds from court costs and fees, not taxpayer dollars. Recipients generally include domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers, and other similar governmental and nonprofit agencies that provide direct services to crime victims. Our unit also administers the Rape Crisis Fund, a fund included in the Governor's budget to assist Rape Crisis Centers throughout the state.

Due to an increase in VOCA funds, every Ohio county shared in more than \$52 million in grants distributed to over 300 organizations in fiscal year 2015. Some of the new programs being funded this year include:

- Domestic Violence Relocation Grant: \$250,000 – Funds will be provided to the Ohio Domestic Violence Network to help relocate survivors of domestic violence who need emergency housing across the state. The grant will help pay for some living expenses, moving expenses, and utility deposits for victims of domestic violence.
- Logan County Domestic Violence Shelter: \$416,675 – Funds will be provided to Consolidated Care Inc. to be used toward establishing a domestic violence shelter in Logan County that will be a 24-hour safe and secure emergency location providing food, clothing, and personal items for survivors' immediate needs. Logan County does not currently have a domestic violence shelter.
- Statewide Rape Crisis Hotline: \$1,253,087 – Funds will be provided to the OhioHealth Sexual Assault Response Network of Central Ohio to develop and implement a 24-hour statewide sexual violence hotline to serve survivors of sexual and relationship violence across the state.
- Sexual Assault Nurse Examiner (SANE) Grants: \$580,465 – Six grants adding up to \$580,465 will be given to Akron General Medical Center, Mount Carmel Medical Center, Townhall II of Kent, Crime Victim Services of Allen County, Cleveland Clinic/Fairview Hospital, and Southwest Community Health Foundation to increase the number of Sexual Assault Nurse Examiners (SANEs) in Ohio. SANEs are specifically trained to conduct sexual assault exams, support victims during the sexual assault exam process, and testify in court if needed.

- Improving Access to Sexual Assault Services for the Disabled: \$75,371 – Funds will be provided to Disability Rights Ohio to provide more robust advocacy for those with disabilities and provide individualized one-on-one support for victims of sexual assault to help them access services, seek justice, and access recovery programs. Funds will also be used to train advocates with Helpline of Delaware and Morrow Counties, New Directions of Knox County, and the Sexual Assault Response Network of Central Ohio on how to best assist victims with disabilities.

The Grants Unit is also providing \$3 million in grants to colleges and universities to strengthen their sexual assault victim advocacy programs. Ohio's public and private colleges and universities, as well as non-profit organizations that work with survivors of campus sexual assault, are eligible to apply for the grants. The funding will be used to provide direct victim services, such as crisis response, hospital advocacy, criminal justice advocacy, and campus judicial system advocacy, to survivors of sexual assaults that take place on Ohio campuses. Our unit also provided \$1 million from the Rape Crisis Fund. This funding was distributed evenly among rape crisis centers, with additional funding awarded to the Ohio Alliance to End Sexual Violence, which is the state sexual assault coalition. In the current awarding period, programs are receiving \$45,804 per program.

Education and Policy Unit

The Education and Policy Unit has created a comprehensive model to ensure equitable access to quality services for victims throughout the state. Unit staff provides training and technical assistance and develops resources for professionals who assist victims. The unit also works to advance policies that secure rights and protections for victims. During fiscal year 2015, more than 4,000 individuals received some form of assistance from the team. Here is a look at assistance provided on various topics in fiscal 2015:

Domestic Violence/Sexual Assault

Crime Victim Services offers training and technical assistance to first responders to improve the response to victims of DV/SV.

In fiscal 2015, the section's DV/SV Program provided training related to investigation, medical assessment, prosecution, and coordinated response to the needs of survivors.

- The Interpersonal Violence Response Training Team (IVPTT) consists of experts in the area of DV/SV who provided six trainings that ranged from basic response to victim needs to advanced information on stalking, lethality assessment, and trauma-informed investigations. Over 400 individuals were trained throughout the state.
- The Victim Coordinator became recognized as an expert witness for court cases related to DV/SV. At the request of county prosecutors the Coordinator testified about the dynamics of domestic violence and sexual assault on two cases.

Sexual Assault Forensic Exam program

The Sexual Assault Forensic Exam (SAFE) program spent the last year working with hospitals to address internal processes to ensure exams are accessible and patients aren't billed for services related to their exam. The SAFE program is statutorily mandated by ORC Section 2907.28 to cover medical expenses of patients examined after a sexual assault to ensure the proper collection of

physical evidence for possible prosecution. The SAFE program reimbursed medical facilities for 6,166 exams at a cost of more than \$3.2 million in fiscal year 2015.

The SAFE program made great strides in identifying billing issues, connecting with hospitals and medical staff, and reviewing claims quicker to ensure faster payments. As a result, the following occurred:

- Provided training to five medical facilities on the exam and billing process for SAFE
- Worked with BCI to cross compare the evidence collection kits submitted to the crime lab to those noted as being picked up by local law enforcement in an effort to encourage all kits be submitted for testing.

Victim Information and Notification Everyday

Staff members help crime victims and other concerned citizens gain access to information about the criminal cases and custody status of offenders through the Victim Information and Notification Everyday (VINE) program. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction and Ohio Department of Youth Services systems and county jails by telephone or online 24 hours a day. Individuals can register to be notified via VINEmobile, phone, email, text message (SMS), or text telephone (TTY) device when an offender's custody status changes. Users can also register through their participating state or county toll-free number.

Recent VINE Service Enhancements for 2015 provided the following:

- A new notification was added to absent without leave (AWL), in order to notify victims when an offender moves from an ODRC facility to a county jail.
- Offender data and information is sent to facilities twice per day.
- The database now uses "Expected Release Date" for advanced notifications.
- A warning notice is now prominently displayed on Vine literature advising victims not to use the VINE notification service as their only safety measure.

Here is a look at fiscal year 2015 VINE statistics:

- On average, 75,788 online searches were conducted each month at www.vinelink.com, the primary registration point for Ohio.
- On average, 3,732 new registrations are logged each month.
- VINELink usage increased 4.9 percent over comparable 12-month periods, from 769,863 to 807,555.
- New registrations increased 11.4 percent, from 40,199 to 44,786.
- Phone notifications were up 12.2 percent, from 205,015 to 230,197.
- E-mail notifications increased 13.5 percent, from 53,325 to 60,516.
- The VINEmobile application logged 61,910 site searches in the first full fiscal year of operation.

Youth

Twenty-four law enforcement officers, prosecutors, forensic interviewers, and child protection professionals were trained to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals the necessary skills to conduct competent investigative interviews of child abuse victims.

Support and Outreach Services

The Support and Outreach Services Unit provides direct victim advocacy and educates communities about available crime victim services. The unit coordinates training, special events and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing education credits.

Through training, technical support, community events and publication distribution, the unit supports local communities with a multidisciplinary approach.

The 24th annual Two Days in May Conference on Victim Assistance was organized by the unit. The conference is the nation's largest conference on victim assistance. Over 1,100 people attended the 2015 conference, themed *Advancing Advocacy for All Crime Victims*. In addition, 48 victim advocates and criminal justice professionals were trained through the Basic Advocacy Skills in Crime Victim Services Academy in fiscal year 2015.

After its initial contact with a victim of crime, the law enforcement agency responsible for investigating the crime must promptly provide the victim in writing an explanation of his or her rights. To facilitate that service, the Crime Victim Services Section produces the Ohio Crime Victim Rights Booklet, an overview of the special rights and privileges accorded victims of crime under Ohio law. In 2015, the section distributed 36,885 booklets to 286 agencies.

Crime Victim Compensation Program

Chapter 2743 of the ORC governs the compensation program, which allows applicants to be reimbursed up to \$50,000 for economic losses they incur as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses
- Funeral and burial expenses (up to \$7,500)
- Dependents' economic losses resulting from the death of a victim
- Counseling expenses for immediate family members of victims of domestic violence, sexual assault, homicide, or a crime that has resulted in a severe and permanent incapacitating injury, such as paraplegia (up to \$2,500 per family member)
- Crime scene cleanup expenses (up to \$750)
- Compensation for property held as evidence (up to \$750).

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payor of last resort and will not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must not have engaged in any conduct that substantially contributed to the injuries sustained
- Must not have engaged in violent felonious conduct or drug trafficking within 10 years of the incident for which the claim has been filed with this office
- Must not have any felony convictions, domestic violence convictions, or child endangering convictions within 10 years of the incident for which the claim has been filed with this office.

Administrative Costs

Administrative costs for fiscal year 2015 totaled \$6,018,010. The number of appeals to the Court of Claims increased from 55 to 65.

The Attorney General's costs increased 3.7 percent, from \$5,802,212 to \$6,018,010. As this involved 4,616 claims, the Attorney General's cost per claim averaged \$1,304.

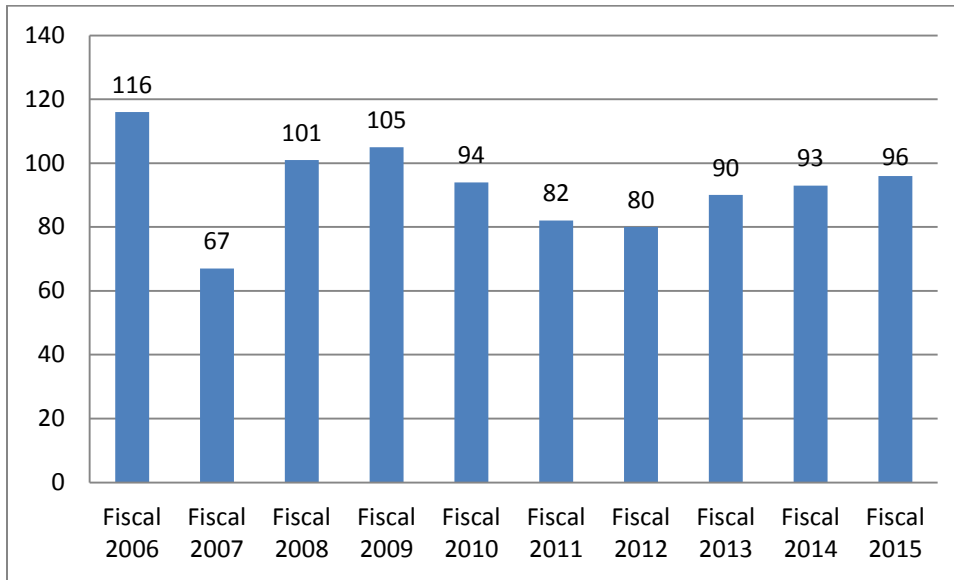

Application and Award Summary

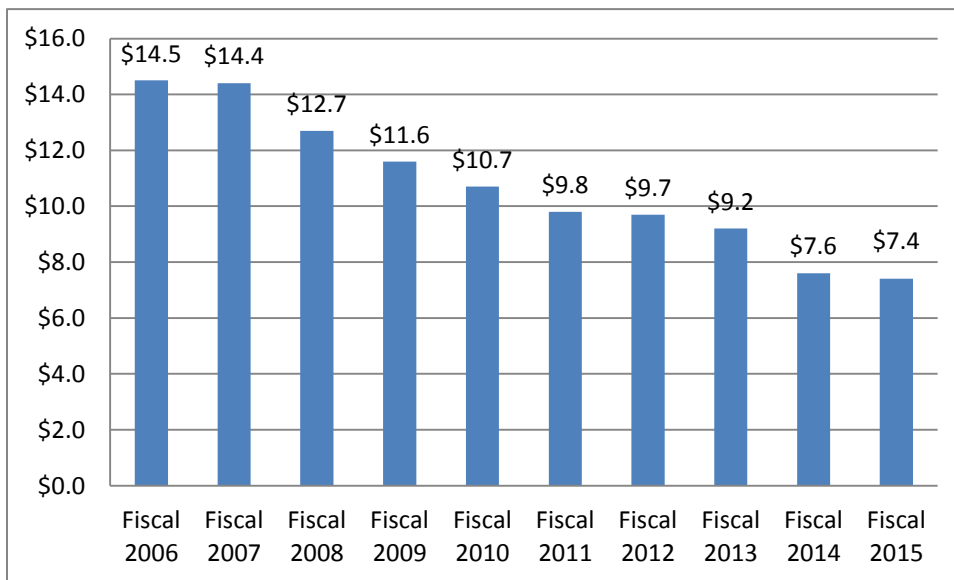
The Compensation Unit processed more than 4,616 compensation claims in fiscal year 2015. The average award for claims totaled \$2,530, up from \$2,401 the year before. The total amount paid to crime victims throughout the state was \$7,460,039 in fiscal year 2015. The number of supplemental claims continues to decrease as the Attorney General's Office makes a concerted effort to consider all out-of-pocket expenses incurred by the applicant in the initial claims, thereby reducing the need for supplemental claims. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available.

Yearly Average Processing Time (in days)

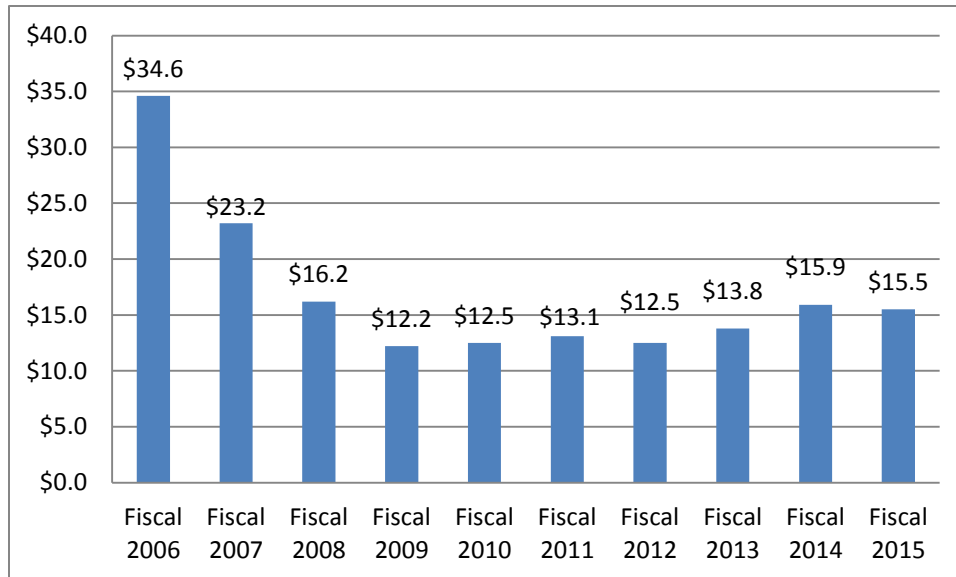


Yearly Compensation Payout (in millions)

The fund's balance has declined over the past 10 years, but has stabilized in recent years, as illustrated in the chart below. Fiscal year 2015 saw a decrease in the fund total of 2.1 percent.



Attorney Fees

Two types of attorney fees are payable under the crime victim compensation statute.

Under ORC Section 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The \$168,969 in attorney fees paid out in fiscal year 2015 represents a 14.4 percent increase from the previous year.

Under ORC Section 2743.51(F)(4), attorneys who assist the claimant with successfully obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding \$1,000, at a rate not exceeding \$100 per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding \$30 per hour. The total amount paid to attorneys assisting with protection orders decreased 7.3 percent in fiscal year 2015, from \$394,814 to \$365,646.

Awards by Incident Type

As in past years, the majority of the awards paid went to victims of assault (44.1 percent). Next were awards related to incidents of domestic violence (17.9 percent) and sexual assault (11.2 percent).

Subrogation

The Attorney General holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies, and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, which included returning \$474,293 to the fund in fiscal year 2015, a 20.5 percent increase over the year before.
