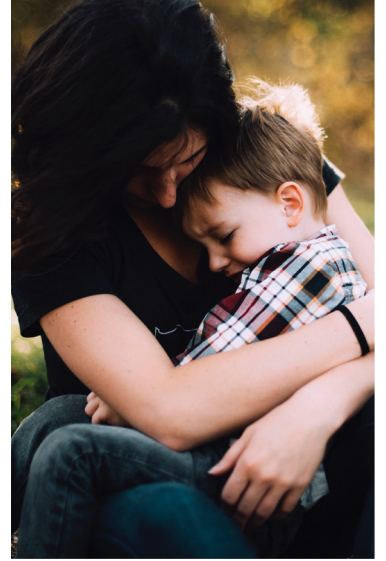

Dear Colleagues,

The Crime Victims Services Section of my office specializes in helping vulnerable Ohioans transition from victims to survivors. One of our most important tools is the Ohio Victims of Crime Compensation Fund, which reimburses the costs of medical expenses, crime-scene cleanup, counseling and other services that crime victims and their families need to heal and move forward with their lives.

Since 1976, the fund has paid out more than \$398 million to victims. In fiscal year 2022 – which ran from July 1, 2021, through June 30, 2022 – my office paid out 1,746 claims averaging \$3,490 each.

Separately, my office has repeatedly advocated for Congress to bolster and preserve the level of funding in the federal Victims of Crime Act (VOCA) Fund by ensuring that financial penalties from deferred prosecution and non-prosecution agreements are treated the same way as penalties resulting from criminal convictions. All such penalties must go to serve and compensate crime victims.

Among our other efforts in fiscal year 2022:

- The Sexual Assault Forensic Exam program reimbursed medical facilities for 5,971 exams at a cost of more than \$3.7 million. The program helps to ensure that evidence is properly collected for possible prosecution and that patients are not forced to pay extra because they were assaulted.
- Using federal VOCA funding, my office awarded more than \$36 million in grants to 345 community agencies, including trauma recovery centers operating in Cuyahoga, Franklin, Lucas and Clark counties.
- Crime Victim Services staff members trained more than 2,800 people on a wide range of topics, including victim compensation, elder abuse, domestic violence, sexual assault and child abuse. The 30<sup>th</sup> edition of the Two Days in May Conference on Victim Assistance was held in person for the first time since the start of COVID-19 pandemic.

Per Ohio Revised Code Section 2743.69, this report details the above efforts and many others made by my office to assist crime victims and the advocates who work on their behalf. If you have questions or comments, please contact Crime Victim Services at 614-466-5610.

## Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred on July 1, 2000, from the Court of Claims to the Ohio Attorney General's Office. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section:

- Administers state and federal grants to support communities' victim assistance programs.
- Provides education and training for victims, victim advocates and the general public.

## Grants Unit

The Grants Unit of the Crime Victim Services Section administers grants from the State Victims Assistance Act (SVAA) and the federal Victims of Crime Act (VOCA), which are funded not by taxpayer dollars but by court costs and fees. Recipients generally include domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers and other similar governmental and nonprofit agencies that directly serve crime victims.

VOCA funds provided to Ohio in fiscal year 2022 were down an additional 38% from the previous year's 26% reduction from fiscal year 2020, leaving approximately 345 programs to share \$36 million in grant funding. This cut reflects a reduction of \$81 million since the 2019 grant cycle.

The Grants Unit also administers the Rape Crisis Fund, which provided more than \$9 million to rape crisis centers. The funding provides direct victim services — crisis response, hospital advocacy, criminal justice advocacy and more — to survivors of sexual assault statewide. In fiscal year 2022, 36 agencies received grants of various amounts to assist victims. The Ohio Alliance To End Sexual Violence was awarded \$950,000 to provide training and technical assistance to rape crisis centers throughout the state.

In another of the unit's programs, Ohio's Domestic Violence Fund grants a consistent funding source to organizations that provide core services to victims of domestic violence. Examples include emergency shelter and counseling. This fund provided more than \$4.9 million to Domestic Violence Providers. In fiscal year 2022, 73 agencies received various amounts to assist victims. The Ohio Domestic Violence Network was awarded \$450,000 to provide training and technical assistance to domestic violence providers throughout the state.

The Grants Unit also provides funding for 1-844-OHIO-HELP, a statewide sexual violence helpline started by the Attorney General's Office and operated by OhioHealth's Sexual Assault Response Network of Central Ohio. The 24/7 phone center received 904 calls in fiscal 2022.

## Victim Service Initiatives

The Victim Service Initiatives Unit:

- Provides training and technical assistance for victim services professionals and develops resources for them.
- Provides direct victim advocacy and educates communities about available crime victim support services.
- Coordinates training, special events and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing-education credits.

The unit's 30th edition of the Two Days in May Conference on Victim Assistance was held May 9-10, 2022; this was the first in-person conference since the start of the COVID 19 pandemic. The conference, organized around the theme "A Celebration of Resiliency," was attended by 867 people and covered a wide range of topics including collaborative community responses, survivor agency within the legal system, and fostering victim resiliency through ethical storytelling. The unit's five-day Basic Advocacy Skills in Crime Victim Services (BASICS) Academy was canceled due to the COVID-19 pandemic. The unit is using this time of transition as an opportunity to re-evaluate BASICS, with the goal of ensuring that the training format and content are both relevant and meaningful for professionals new to the field of victim's services in Ohio.

The unit produces the Ohio Crime Victims' Rights Booklet, an explanation of the compensation and legal systems for crime victims. In fiscal year 2022, the section distributed 17,300 booklets to 121 law enforcement agencies, which are required to provide a crime victim a written explanation of his or her rights promptly after making initial contact.

The unit also works to advance policies that secure rights and protections for victims. During the fiscal year, 2,806 people received some form of training and technical assistance from the unit in areas that included the following:

### **Sexual Assault Forensic Examination (SAFE) Reimbursement and Kit Tracking**

Crime Victim Services offers training and technical assistance throughout the state on SAFE Reimbursement and the Sexual Assault Kit Tracking System (SAKT); five such trainings were conducted in fiscal year 2022. The SAFE Reimbursement Program pays for the cost of the evidence kit collection/forensic (genital) examination and the antibiotic prophylaxis to prevent sexually transmitted infections. The SAKT System allows victims to anonymously check the current status of their Sexual Assault Evidence Kit (SAEK); to date, more than 7,500 kits have been tracked in the system, with nearly 6,300 kits completing the process.

## **Sexual Assault Forensic Exam program**

The Sexual Assault Forensic Exam (SAFE) program is statutorily mandated by Ohio Revised Code Section 2907.28 to cover medical expenses for examinations of patients after a sexual assault, both to ensure the proper collection of evidence for possible prosecution and to ensure the patient is not forced to pay. The program reimbursed medical facilities more than \$3.7 million for 5,921 exams in fiscal year 2022.

In October 2017, the SAFE program began reimbursing hospitals that provide HIV-prevention treatment to victims who might have been exposed to the disease. In collaboration with the Ohio Department of Health, a risk-exposure protocol was developed as part of the state's medical forensic exam process. Ohio Administrative Code Section 109:7-1-02(B) states: "A hospital, children's advocacy center, or other emergency medical facility shall accept payment of the actual amount billed; not to exceed twenty-five hundred dollars, as payment in full for any cost incurred in administration of HIV post-exposure prophylaxis protocol in rule 109:7-1-01 of the Administrative Code." The HIV program issued payments totaling \$859,300.98 in fiscal year 2022.

## **Victim Information and Notification Everyday**

The Victim Information and Notification Everyday (VINE) program helps crime victims and other concerned citizens gain access to information about the criminal cases and custody status of offenders. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction, the Ohio Department of Youth Services and county jails. Individuals can register to be notified by phone, email, text or TTY device when an offender's custody status changes. Users can register through their participating state toll-free number, VINELink mobile app, VINE MobilePatrol app or VINELink.com.

In fiscal year 2022:

- On average, 626,157 online searches were conducted monthly at [www.vinelink.com](http://www.vinelink.com), the primary registration point for Ohio.
- On average, 9,089 new registrations were logged each month.
- VINELink usage decreased 25.4% over comparable 12-month periods, from 1,129,753 to 842,795.
- New registrations increased 25.1%, from 87,212 to 109,067.
- Phone inquiries increased 107.3%, from 16,094 to 33,363.
- Email notifications increased 1.2%, from 148,890 to 150,634.
- SMS Text Messaging Notification increased 96.3%, from 64,720 to 127,036 events.
- MobilePatrol searches totaled 6,642,750.

## **Child victim trial preparation training**

Thirty enforcement officers, prosecutors, forensic interviewers and child protection professionals were trained in December 2021 to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals the skills necessary to conduct competent investigative interviews of child abuse victims.

## Crime Victim Compensation Program

Chapter 2743 of the Ohio Revised Code governs the compensation program, which allows applicants to be reimbursed as much as \$50,000 for economic losses incurred as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses.
- Funeral and burial expenses (up to \$7,500).
- Dependents' economic losses resulting from the death of a victim.
- Crime scene cleanup expenses (up to \$750).
- Compensation for property held as evidence (up to \$750).

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payer of last resort; it does not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must file a police report and cooperate with law enforcement.
- Must file their application within three years of the date of the incident.
- Must not have engaged in any conduct that substantially contributed to the injuries suffered except in homicide claims.

The Ohio Legislature passed Senate Bill 36, which took effect March 1 and did the following:

- Removed criminal backgrounds as eligibility disqualifiers.
- Removed possession of felony drugs as a disqualifier.
- Removed contributory misconduct as a disqualifier in homicide claims.
- Changed the statute of limitations to three years from the date of the incident for adults. Victims under 21 at the time of the crime have until their 24<sup>th</sup> birthday to file.

## Administrative Costs

In terms of the compensation fund, administrative costs for fiscal year 2022 totaled \$5,882,003.

As noted earlier, responsibility for the compensation fund originated with the Court of Claims. The compensation fund continues to fund some court expenses, including work on appeals of decisions made by the Attorney General's Compensation Unit (ORC 2743.531). The number of appeals to the Court of Claims increased from 27 to 40.

The costs to the Attorney General Office's increased 5.7% – from \$5,562,354 to \$5,882,003

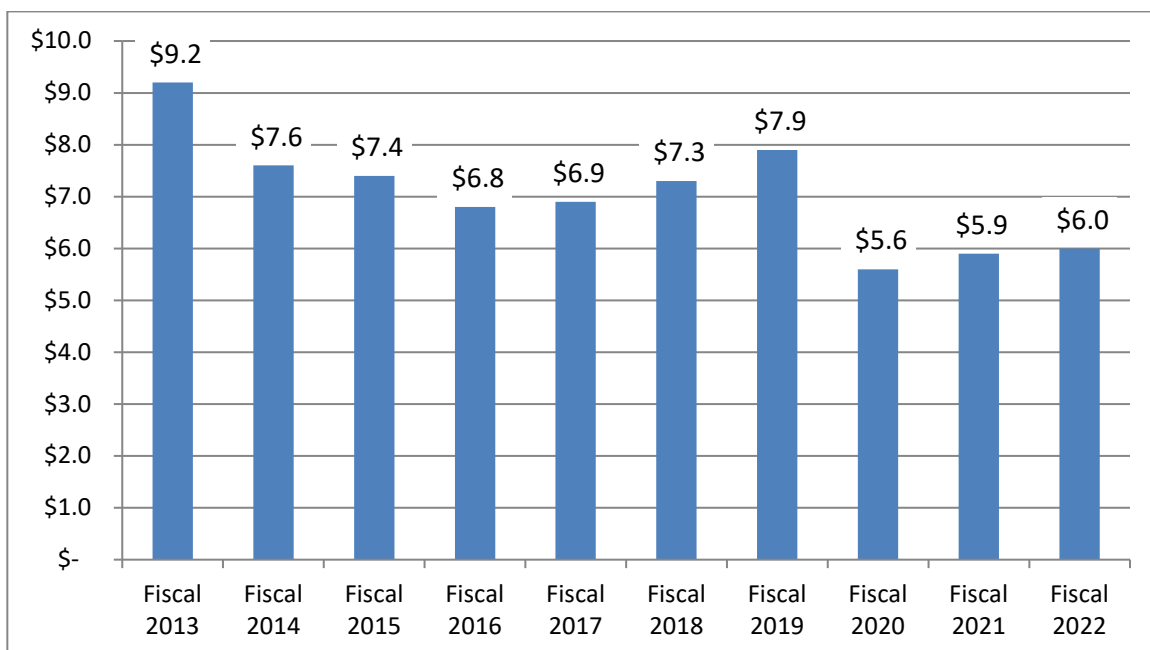


## Application and Award Summary

The Compensation Unit processed 4,504 new original compensation claims during the fiscal year. The average award for original claims totaled \$3,355. The total amount paid to crime victims throughout the state was \$6,094,249 in the fiscal year. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available

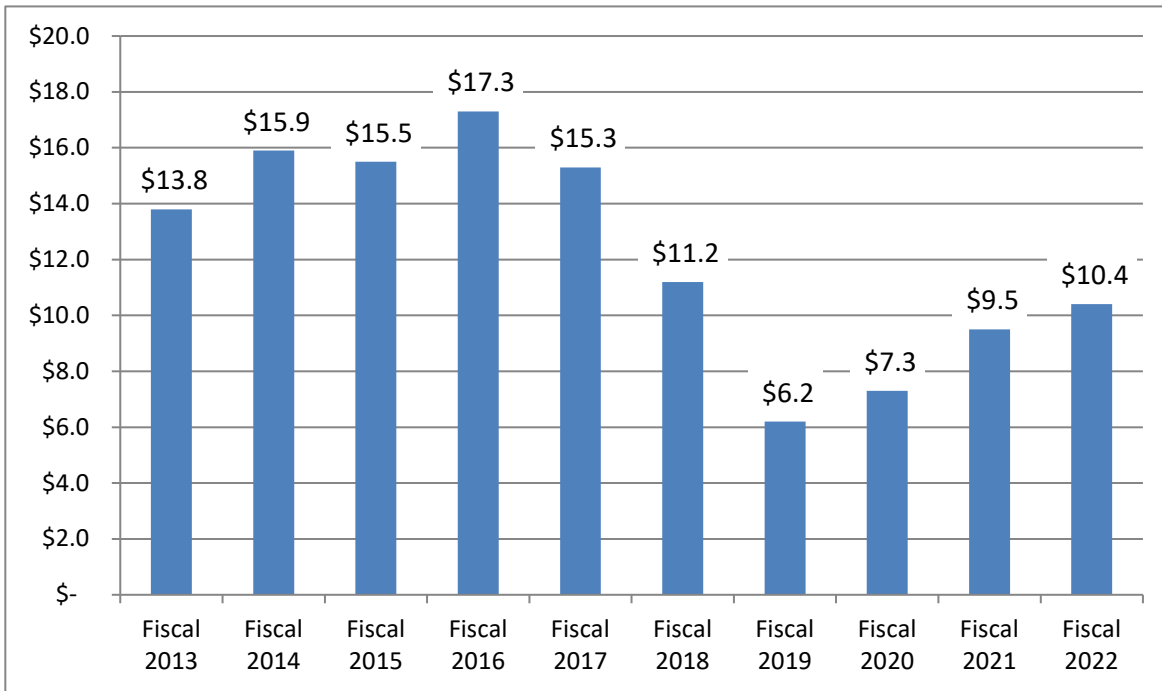

## Fund Balance for Fiscal 2013 through 2022 (in Millions)

The fund's balance had fallen in recent years, as illustrated in the chart below. Fiscal year 2022 saw an increase in the fund total of 9.9%.



The fund balance had been decreasing due to a combination of factors, including lower federal funding. Also, in fiscal years 2017, 2018 and 2019, almost \$1.5 million was sent each year to the Bureau of Criminal Investigation for DNA work to help solve crimes for victims; in fiscal year 2017, the SAFE program increased the amount paid to medical centers from \$532 to \$632 per sexual assault kit; and revenue provided by court costs and fees has been decreasing since fiscal year 2016.

However, in fiscal year 2020, measures were taken to secure the fund by finding another funding source for the DNA work and securing a grant to pay for the majority of the SAFE program including the General Revenue Fund (GRF) in fiscal year 2022.

## Attorney Fees

Two types of attorney fees are payable under the crime victim compensation statute.

Under ORC 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The \$69,318 in attorney fees paid out in the fiscal year represents a 44.3% decrease from the previous year's \$124,421.

Under ORC 2743.51(F)(4), attorneys who assist the claimant with successfully obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding \$1,000, at a rate not exceeding \$100 per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding \$30 per hour. The total amount paid to attorneys assisting with protection orders decreased 31.8% in fiscal year 2022, from \$232,496 to \$158,457.

## Claims Paid by Incident Type

As in past years, the majority of the claims paid went to victims of assault (37.3%), followed by awards related to homicide (31.9%) and child sexual abuse (7.8%).

## Subrogation

The Attorney General holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, which included returning \$476,442 to the fund in fiscal year 2022, a 13.2% increase from the previous fiscal year.
