Dear Colleagues,

The Crime Victims Services Section of my office specializes in helping vulnerable Ohioans transition from victims to survivors. One of our most important tools is the Ohio Victims of Crime Compensation Fund, which reimburses the costs of medical expenses, crime-scene cleanup, counseling and other services that crime victims and their families need to heal and move forward with their lives.

Since 1976, the fund has paid out more than \$406 million to victims. In fiscal year 2023 – which ran from July 1, 2022, through June 30, 2023 – my office paid out 1,927 claims averaging \$3,984 each.

Separately, my office has repeatedly advocated for Congress to bolster and preserve the level of funding in the federal Victims of Crime Act (VOCA) Fund by ensuring that financial penalties from deferred prosecution and non-prosecution agreements are treated the same way as penalties resulting from criminal convictions. All such penalties must go to serve and compensate crime victims.

Among our other efforts in FY 2023:

- The Sexual Assault Forensic Exam program reimbursed medical facilities for 5,211 exams at a cost of more than \$3.2 million. The program helps to ensure that evidence is properly collected for possible prosecution and that patients are not forced to pay extra because they were assaulted.
- Using federal VOCA funding, my office awarded more than \$37 million in grants to 288 community agencies, including trauma recovery centers operating in Cuyahoga, Franklin, Lucas and Clark counties.
- Crime Victim Services staff members trained more than 2,600 people on a wide range of topics, including victim compensation, elder abuse, domestic violence, sexual assault and child abuse.
- The 31st edition of the Two Days in May Conference on Victim Assistance was held on May 8-9, 2023, drawing 976 attendees.

Per Ohio Revised Code Section 2743.69, this report details the above efforts and many others made by my office to assist crime victims and the advocates who work on their behalf. If you have questions or comments, please contact Crime Victim Services at 614-466-5610.

Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred on July 1, 2000, from the Court of Claims to the Ohio Attorney General's Office. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section:

- Administers state and federal grants to support communities' victim assistance programs.
- Provides education and training to victims, victim advocates and the public.

Grants Unit

The Grants Unit of the Crime Victim Services Section administers grants from the State Victims Assistance Act (SVAA) and the federal Victims of Crime Act (VOCA), which are funded by court costs and fees. Recipients generally include domestic-violence shelters, prosecutor-based victim/witness programs, child advocacy centers, and other similar governmental and nonprofit agencies that directly serve crime victims.

The \$49.9 million in VOCA funding provided to Ohio for FY 2023 represents a 38.3% increase over that of the previous fiscal year but is significantly less — \$67.4 million — than the \$117.3 million allocated in FY 2019 and a \$22.8 million decrease over the average for the past four fiscal years. During the fiscal year, 326 programs received VOCA funding.

The Grants Unit also administers the Rape Crisis Fund, which in FY 2023 provided more than \$7.2 million to rape crisis centers. Thirty-six agencies received grants of varying amounts. The funding provides direct victim services — crisis response, hospital advocacy, criminal justice advocacy and more — to survivors of sexual assault statewide. The Ohio Alliance to End Sexual Violence was awarded \$950,000 to provide training and technical assistance to rape crisis centers throughout the state.

Another Grants Unit program, the Ohio's Domestic Violence Fund, funds organizations that provide emergency shelter, counseling and other core services to victims of domestic violence. This fund provided more than \$2.5 million to domestic-violence providers, with 77 agencies receiving an award. The Ohio Domestic Violence Network was awarded \$450,000 to provide training and technical assistance to domestic-violence providers statewide.

The Grants Unit also provides funding to 1-844-OHIO-HELP, a statewide sexual violence helpline started by the Attorney General's Office and operated by OhioHealth's Sexual Assault Response Network of Central Ohio. The 24/7 phone center received 339 calls in FY 2023.

Victim Service Initiatives Unit

The Victim Service Initiatives Unit:

- Coordinates training and technical assistance for victim-services professionals, develops resources for them, and provides a way to link organizations to achieve common goals.
- Educates communities about available support services for crime victims.
- Facilitates training, special events and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing-education credits.

The unit's 31st edition of the Two Days in May Conference on Victim Assistance, with the theme of "Empowering Survivors to Rebuild Lives," took place on May 8-9 in Columbus. The event drew 976 attendees, including presenters and AGO volunteers, to its 35 workshops. The keynote speakers were Tony Porter, CEO of A Call to Men, who presented his innovative research on breaking the cycle of gender-based violence by redefining society's definition of manhood, and Ruth Bowdish, who brought a positive message of hope and resilience to victims and survivors.

The workshops covered new concepts, such as Fawn (the forgotten trauma response) and how to engage men/boys to improve services for male sexual assault survivors, as well as boots-on-the-ground practical topics, such as barriers that certain communities and populations face in accessing care and an update on the latest changes in domestic-violence laws.

Since the pandemic, the unit has been working to resurrect its BASICS Academy, which provides at least 40 hours of training to credential new advocates. An updated curriculum is being developed, one involving both in-person and virtual training and assigned mentorships. The first academy since the pandemic is targeted for early 2024.

Also in fiscal year 2023, the unit twice conducted Finding Words Ohio, a specialized training for professionals across disciplines in best practices for conducting forensic interviews of child sex-abuse victims. The goal is to employ care and diligence in preparing young victims and the case for prosecution.

Until April 6, the unit was responsible for printing and distributing the "Ohio Crime Victims' Rights" booklet, sending 10,050 copies to advocates in prosecutor's offices and nonprofit agencies and 14,950 copies to law enforcement agencies. With the codification of Marsy's Law in Ohio, however, the requirements changed. After April 6, the unit printed and distributed 69,775 two-sided "Crime Victims' Rights" informational cards (often called *palm cards*) and an equal number of "Crime Can Be Costly" palm cards, which outline the Ohio's Crime Victim Compensation program.

The unit also works to advance policies that secure rights and protections for victims. During the fiscal year, 2,656 people received some form of training and technical assistance from the unit in areas that included the following:

Sexual Assault Forensic Examination (SAFE) reimbursement and kit tracking

Crime Victim Services offers training and technical assistance statewide on SAFE reimbursement and the Sexual Assault Kit Tracking System (SAKT), with two trainings conducted in FY 2023. The SAFE Reimbursement Program covers the costs of the evidence kit collection/forensic (genital) examination and the antibiotic prophylaxis to prevent sexually transmitted infections. The SAKT System allows victims to anonymously check the current status of their Sexual Assault Evidence Kit (SAEK). To date, more than 9,756 kits have been tracked in the system, with nearly 8,624 of those kits completed.

Sexual Assault Forensic Exam program

The Sexual Assault Forensic Exam (SAFE) program is statutorily mandated by Ohio Revised Code Section 2907.28 to cover medical expenses for examinations of patients after a sexual assault, both to ensure the proper collection of evidence for possible prosecution and to ensure that the patient is not forced to pay. The program reimbursed medical facilities more than \$3.2 million for 5,211 exams in FY 2023.

In October 2017, the SAFE program began reimbursing hospitals that provide HIV-prevention treatment to victims who might have been exposed to the disease. In collaboration with the Ohio Department of Health, a risk-exposure protocol was developed as part of the state's medical forensic exam process. Ohio Administrative Code Section 109:7-1-02(B) states: "A hospital, children's advocacy center, or other emergency medical facility shall accept payment of the actual amount billed; not to exceed twenty-five hundred dollars, as payment in full for any cost incurred in administration of HIV post-exposure prophylaxis protocol in rule 109:7-1-01 of the Administrative Code." In FY 2023, the HIV program issued payments totaling nearly \$1.08 million.

Victim Information and Notification Everyday

The Victim Information and Notification Everyday (VINE) program helps crime victims and other concerned citizens access information about the criminal cases and custody status of offenders. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction, the Ohio Department of Youth Services and county jails. Individuals can register to be notified by phone, email, text or TTY device when an offender's custody status changes. Users can register through their participating state toll-free number, VINELink mobile app, VINE MobilePatrol app or VINELink.com.

In fiscal year 2023:

- An average of 675,372 online searches were conducted each month at www.vinelink.com, the primary registration point for Ohio.
- An average of 12,289 new registrations were logged each month.
- VINELink usage increased 198.2% over comparable 12-month periods, to 2,513,001 from 842,795.
- New registrations increased 35.2%, to 147,470 from 109,067.
- Phone inquiries decreased 45.1%, to 18,310 from 33,363.
- Email notifications increased 9.0%, to 164,226 from 150,634.
- SMS Text Messaging Notification increased 19.9%, to 152,306 events from 127,036.
- MobilePatrol searches totaled 5,581,057.

Best-practices training in preparing child victims for trial

Fifty-eight law enforcement officers, prosecutors, forensic interviewers and child protection professionals were trained during FY 2023 to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals how best to conduct competent investigative interviews of child abuse victims.

Crime Victim Compensation Program

Chapter 2743 of the Ohio Revised Code governs the compensation program, which allows applicants to be reimbursed as much as \$50,000 for economic losses incurred as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses.
- Funeral and burial expenses (up to \$7,500).
- Dependents' economic losses resulting from the death of a victim.
- Crime scene cleanup expenses (up to \$750).
- Compensation for property held as evidence (up to \$750).

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payer of last resort; it does not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must file a police report and cooperate with law enforcement.
- Must file an application within three years of the date of the incident.
- Must not have engaged in any conduct that substantially contributed to the injuries suffered, except in homicide claims.

The Ohio Legislature passed Senate Bill 288, which:

- Permits the Attorney General to grant an emergency award for funeral expenses to indigent claimants who will suffer undue hardship if immediate economic relief is not obtained.

The Ohio Legislature passed House Bill 343, which:

- Provides for additional court cost and bail for reparations fund.
- Allows the court to order restitution in a juvenile delinquency offense.
- Prohibits a court that has ordered restitution on an offender for a felony to discharge restitution until it is fully paid by the offender.
- Requires that all money remaining unclaimed for the restitution payment to crime victims be sent to the Reparations Fund with a list from the clerk specifying the amounts and individual identifying information.

The Ohio Legislature passed Senate Bill 16, which:

- Revises the format and content of the information provided to victims regarding crime victim compensation.
- Modifies procedures for the law enforcement agencies upon initial contact with the victim, including materials and information that must be provided to the victim.
- Specifies that the Crime Victim Bill of Rights be made available on the Attorney General's website.
- Requires law enforcement agencies, upon initial contact, to provide the victim with the Victim's Rights Request Form, as well as the Crime Victim Bill of Rights palm card and the victim compensation information card.

Administrative costs

In terms of the compensation fund, administrative costs for FY 2023 totaled \$5,781,955.

As noted earlier, responsibility for the compensation fund was originally assigned to the Court of Claims. The fund continues to fund some court expenses, including work on appeals of decisions made by the Attorney General's Compensation Unit (ORC 2743.531). The number of appeals to the Court of Claims decreased from 40 to 34 in FY 2023.

The costs to the Attorney General Office decreased 1.7% – from \$5,882,003 to \$5,781,955.

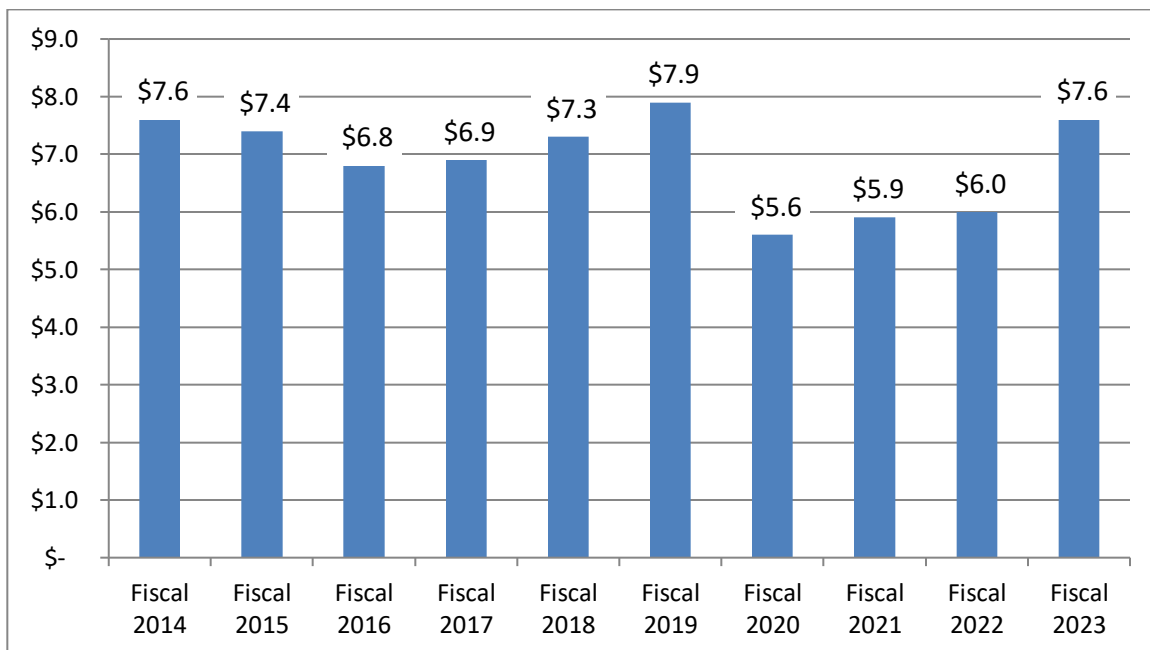

Application and award summary

The Compensation Unit processed 5,077 original compensation claims during the fiscal year. The average award for original claims totaled \$3,711. The total amount paid to crime victims throughout the state during the fiscal year was \$7,676,704. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available.

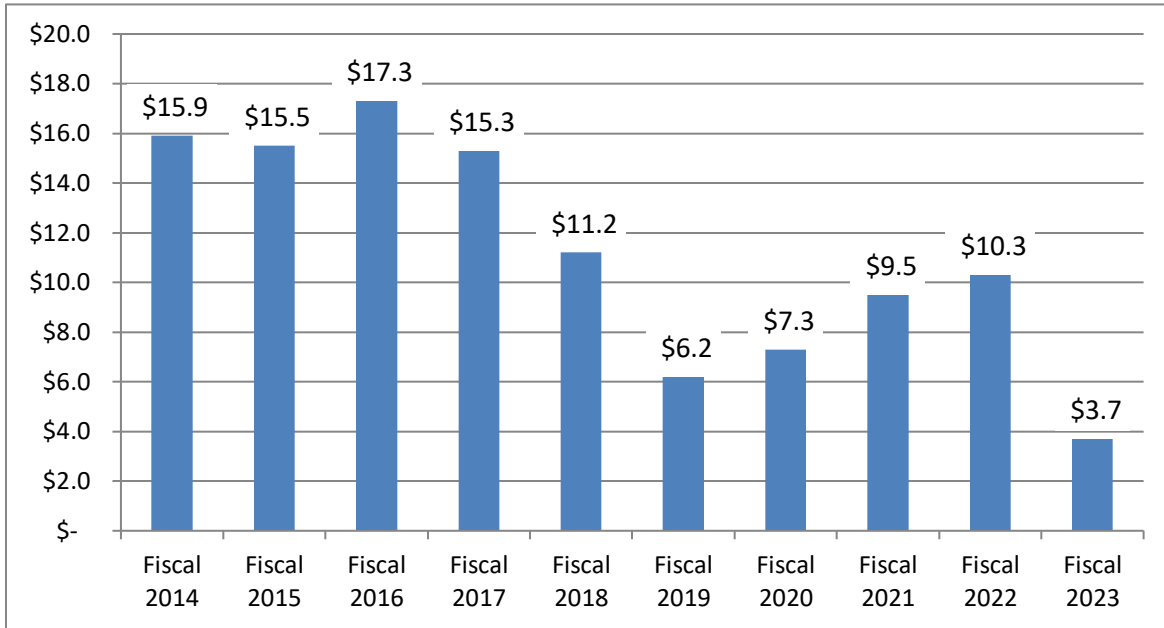

The fund's balance has fluctuated in recent years, with FY 2023 seeing a 63.8% decrease over the previous fiscal year because grant and General Revenue Fund money were not available for SAFE and claim payments.



The fund balance in recent years has been significantly lower than it was prior to FY 2018. The shift is due to a combination of factors, including a reduction in federal funding. Also, in fiscal years 2017, 2018 and 2019, almost \$1.5 million a year was sent to the Bureau of Criminal Investigation for DNA work to help solve crimes for victims; in fiscal year 2017, the SAFE program increased the amount paid to medical centers from \$532 to \$632 per sexual assault kit; and revenue provided by court costs and fees has been decreasing since fiscal year 2016.

However, in FY 2020, measures were taken to secure the fund by finding another funding source for the DNA work and securing a grant to pay for the majority of the SAFE program, including the General Revenue Fund (GRF) in fiscal year 2022.

Attorney fees

Two types of attorney fees are payable under the crime victim compensation statute.

Under ORC 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The \$54,455 in attorney fees paid out in the fiscal year represents a 21.4% decrease from the \$69,318 paid out in FY2022.

Under ORC 2743.51(F)(4), attorneys who successfully assist a claimant with obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding \$1,000, at a rate not exceeding \$100 per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding \$30 per hour. The total amount paid to attorneys assisting with protection orders increased 17.0% in fiscal year 2023, to \$185,429 from \$158,457.

Claims paid by incident type

As in previous years, the majority of the paid claims went to victims of assault (43.1%), followed by awards related to homicide (32.1%) and child sexual abuse (5.5%).

Subrogation

The Attorney General's Office holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, including returning \$496,040 to the fund in FY 2023, a 4.1% increase from that of the previous fiscal year.
