**Narrative:**

On May 13, 2024, at 1030hrs, Special Agent Lurna McClintock and Crime Scene Technician Michael Rostocil assisted Special Agent Valente with documenting clothing and personal belongings of Jason Norris(S) in regard to an officer involved critical incident. The clothing was in the drying room at BCI Richfield, 4055 Highlander Pkwy, Richfield, OH 44286.
