These contracts cover the construction and completion of the plumbing and heating of the addition to the Chemistry Building on the Ohio State University Campus, and call for an expenditure of \$33,500.00; and the construction and completion of the plumbing and heating of the Journalism Building on the Ohio State University Campus, and call for an expenditure of \$20,700.00.
