Narrative:

On Thursday, June 13, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Collins (SA Collins) received training and personnel file records from the City of Columbus– Division of Police (CPD) Sgt. Terry McConnell for CPD [REDACTED] [REDACTED] is a Columbus Police Officer and was involved in a deadly shooting, while on duty, on June 10, 2024. On September 16, 2024, SA Carrie Ryan (SA Ryan) reviewed the training and personnel file records and noted the following:
