APPROVAL—RESERVOIR LAND LEASE, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, TO CHRIST LUDWIGS, COLUMBUS, OHIO, TERM FIFTEEN YEARS, ANNUAL RENTAL \$48.00, RIGHT TO OCCUPY AND USE FOR COTTAGE SITE AND DOCKLANDING PURPOSES, DESIGNATED LAND, BUCKEYE LAKE, FAIRFIELD COUNTY, OHIO.

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Conservation Commissioner, to Christ Ludwigs of Columbus, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$48.00, there is leased and demised to the lessee above named, the right to occupy and use for cottage site and docklanding purposes only, the inner slope and waterfront and the outer slope and borrow pit adjacent thereto of the northern embankment of Buckeye Lake that is included in embankment lot No. 53, west of the water-gates, as laid out by the Ohio Canal Commission in 1905, and being part of the west half of the Northwest Quarter of Section 23, Town 17, Range 18, Fairfield County, Ohio.
