## Narrative:

On May 14, 2024, at approximately 1353 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente responded to the Cuyahoga County Medical Examiner's Office (CCMEO) and met with Evidence Technician Astra Driscoll (Technician Driscoll). Technician Driscoll turned over to SA Valene nine (9) items collected by CCMEO during the autopsy of Jason Norris (Norris). These items consisted of a single projectile collected from Norris's back, various DNA swabs, scalp hair, buccal swabs, a gunshot residue adhesive stub, and a blood stain card. SA Valente signed a CCMEO receipt noting his reception of these items. SA Valente transported these items directly to the BCI Richfield office where they were placed in temporary evidence locker #30 at 1700 hours. SA Valente completed a BCI evidence receipt noting the collection and transfer of these items to the temporary evidence locker. Both evidence receipts were attached to this report.
