On September 20th, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (S/A) Aja Chung received a memory drive from BCI S/A Ryan Scheiderer that contained body worn camera (BWC) and cruiser camera footage from the Franklin County Sheriff's Office (FCSO) and Columbus Police Department (CPD), that pertained to the Officer-Involved Critical Incident that occurred on July 8th, 2023.

- <u>Officer in trouble-62</u>: BWC of CPD Ofc. Matthew Dover. Discussion about possible second subject and Antwan Lindsey residing in apartment 22.
- <u>Officer_in_trouble-41</u>: BWC of CPD **1**. **Interview** indicates he thought he discharged his firearm, gets into cruiser with Officer Support team member and is transported to a substation.
- <u>Officer_in_trouble-36</u>: BWC of CPD Ofc. Ryan McGinty. Discussion amongst other CPD officers about what Lindsey said to them while orders were being given.
- <u>Officer_in_trouble-38</u>: BWC of CPD Ofc. Austin Enos. Discussion amongst same group as in CPD Ofc. McGinty (above). Ofc. with rifle slung indicates he heard what sounded like a gunshot and that's when LE discharged their weapons.

6:33: approaches FCSO who updates Sgt. Mottinger of incident (scene still active).

7:10: FCSO providing other responding units of Lindsey's description

7:25: Sqt. Mottinger approaching 3110 E. Livingston front door and orders clearly being given by CPD officers inside the building.

- 8:00: can hear the taser being deployed
- 8:01: shots fired inside the building

8:11: Sgt. Mottinger radios in "he's shooting at us."

9:41: Sqt. Mottinger advises all involved CPD officers to turn off BWC.

10:00: Sqt. Mottinger (S-12) updates dispatch of number of CPD shooting officers, suspect is down, EMS needed and advises what intersections need to be closed down.

10:24: starts running with other CPD towards front of 3110 (posts on side of building)

 - 6:40: "pull taser" can be heard from front door CPD

9:22: CPD officer is heard giving Lindsey orders not to reach for anything 9:28: decision to use taser is verbalized

9:31: CPD **I** is heard yelling "taser" three (3) times and then deploying taser

9:34: shots fired

7:02: gives orders to Lindsey

7:17: pistol can be seen on floor near Lindsey's feet as he's standing in doorway. Lindsey's hands are not observed

7:29: Lindsey takes a step which slightly moves gun and grabs door with his left hand.

8:07: Lindsey can be seen looking at officers in front of building

8:13: Lindsey says something inaudible

8:13: CPD **Constant of the set of**

 - 5:11: confirms he stepped in a hole
 - 5:18: another CPD unit (Sgt. Mottinger) radios in an AD occurred

8:40: other CPD officer confirms Lindsey was down and a path was needed for the medics

B._Thomas_BWC: (positioned behind Ofc. Cook)
 9:14: enters into the front of 3110; Lindsey can be seen standing in doorway with left hand on door
 9:20: a pistol can be seen on the floor near Lindsey
 9:50: Lindsey is speaking however it is inaudible
 9:59: Lindsey struck by taser and falls on opposite side of the door (in hallway)
 10:01: shots are fired and Ofc. Thomas moves out of way
 10:06: taser wire still attached to _____ taser can be seen
