Narrative:

On Tuesday, June 07, 2022, at 2219 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Collins (SA Collins) interviewed Franklin County Sheriff's Office (FCSO) Deputy (Dep.) [REDACTED] (Dep. [REDACTED]), who was accompanied by his attorney, Lathan Lipperman, from the law offices of Harshman and Wannemacher, consulted from the Fraternal Order of Police. The interview took place at 900 Hague Ave. Also present during the interview was FCSO, Det. Jason Evans. The interview was audio recorded.

SA Collins was informed Dep. [REDACTED] was an involved-officer or had otherwise discharged his weapon during the incident. SA Collins was previously briefed on some of the known circumstances surrounding the event. More specifically, what lead up to the incident. SA Collins was told FCSO SWAT members were conducting surveillance on a subject (Adrian Pozz) wanted for questioning, related to two homicides. Pozz was said to have an active warrant for failure to register as a sex offender. FCSO wished to gather additional information related to the surveillance activity which lead up to the shooting incident at 2280 Stelzer, as it pertained to the active homicide investigation they were conducting. SA Collins spoke with Attorney Lipperman and explained SA Collins wished to gather additional public safety information from Dep. [REDACTED]. Lipperman advised Dep. [REDACTED] was available to speak with SA Collins, only about the events prior to the shooting incident, whereas those details may be provided in a future, formal interview.

Dep. [REDACTED] advised the surveillance activity began at 3659 Foraker Dr. Det. Evans wished to ascertain if there were any other addresses Pozz had stopped at prior to ultimately arriving at 2280 Stelzer Rd. (Sunoco Gas Station). Dep. [REDACTED] stated no. He was asked if there were any other subjects with Pozz who had gotten out of the vehicle prior to arriving at Sunoco and he stated no. Dep. [REDACTED] was asked if he'd witnessed any items being discarded during his surveillance and he stated no. Dep. [REDACTED] was asked if anyone had fled the vehicle or were otherwise unaccounted for. Dep. [REDACTED] stated no.

The interview concluded at approximately 2224 hours.
