On March 1, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong drafted a search warrant for medical records relative to the October 18, 2022, officerinvolved critical incident at Southwest General Medical Center.

At 1115 hours, SA Armstrong met with Cuyahoga County Court of Common Pleas Judge Shannon Gallagher (Gallagher) who reviewed the search warrant, search warrant affidavit, application to seal and order to seal. Judge Gallagher signed/authorized the search warrant and order to seal.

Search Warrant Executed:

On March 1, 2023, at approximately 1155 hours, SA Armstrong executed/served the aforementioned search warrant by submitting it to Nicole Dinger in the Medical Records Department of the Southwest General Medical Center.

On March 9, 2023, SA Armstrong received a copy of the requested medical records. A Certificate of Authenticity for the records was also included. The records were electronically copied and saved on a CD as a .pdf file titled 2023-03-09 Medical Records – Bryan Bailey. They have been stored in the BCI SIU case file as Reference Item D. SA Armstrong completed an inventory and a copy was provided to the Cuyahoga County Clerk of Courts when the search warrant was filed with the court.

Search Warrant Returned:

On March 13, 2023, SA Armstrong met with Judge Nancy Fuerst who reviewed and signed the search warrant return. SA Armstrong then filed the original search warrant, search warrant
