Detective Thelemon Powell #2062 and I were assigned the task of responding to Maple Hts. Police Department and interviewing two males that were under arrest.

These males were in the vehicle that wrecked on Buckeye Avenue while being pursued by Maple Hts. Police Department for a shooting that occurred in their jurisdiction.

The following interview was conducted with Cleveland Police I.A. Sgt. Michael Schwebs #9205.

FIELDS are the parents of C [REDACTED] F [REDACTED] B/M 17 and were on scene. Below is a synopsis of that interview.

I advised the FIELDS that their son was not injured but was under arrested by Maple Hts. Police Department for a shooting that happened in their jurisdiction.

FIELDS stated that their son just had ACL surgery and they do not know why he was not inside the house. FIELDS stated their son is supposed to be walking with the aid of crutches.

FIELDS stated their son was sitting in the gold 2016 Ford Focus with his cousin DECARLO FIELDS in front of their home.

FIELDS stated they do not know the 3rd person that was inside the Ford Focus with their son.

FIELDS was interviewed at the MHPD Jail. FIELDS was advised of his constitutional rights and he waived his rights. **Below is a synopsis of those rights.**

At first FIELDS was very evasive about who was inside the gold 2016 Ford Focus and the events which lead the MHPD Officer's use of deadly force.

FIELDS would not admit that his cousin O [REDACTED] F [REDACTED] was inside the gold Ford Focus and would not acknowledge that "WHEAT" a.k.a DATWUAN CATCHINGS was inside the gold Ford Focus.

FIELDS eventually admitted that he was in the front passenger seat of the gold Ford Focus, O [REDACTED] F [REDACTED] was in the back passenger seat and CATCHINGS was driving the gold Ford Focus.

FIELDS stated that he called CATCHINGS on his cell phone and CATCHINGS picked him up at Clement Avenue and Raymond Avenue.

FIELDS stated they were driving across the bridge and a MHPD police vehicle was traveling in the opposite direction with its lights and siren on.

FIELDS stated the MHPD police vehicle did a U-turn and began following them in the gold Ford Focus.

FIELDS stated that CATCHINGS stated he (Catchings) was not stopping for the MHPD police vehicle and a police pursuit ensued.

FIELDS stated he does not know what happened that caused the MHPD to pursue them. FIELDS stated he does not know anything about a shooting that involved the gold Ford Focus.

FIELDS stated he wanted to get out of the gold Ford Focus but CATCHINGS would not stop the vehicle.

FIELDS stated he does not know what streets they were traveling on in the City of Cleveland. FIELDS stated he just knows that they were being chased by the MHPD and CATCHINGS would not stop the vehicle.

FIELDS stated they were fleeing west on Buckeye Avenue when CATCHINGS struck a deer. FIELDS stated the airbag went off and he covered his head during the impact.

FIELDS stated he, OMARION FIELDS and CATCHINGS all ran in different directions. FIELDS stated he ran into a field and was being pursued by the MHPD officer.

FIELDS stated during the pursuit he injured his left leg and left foot. FIELDS stated he was not injured by the MHPD officer.

FIELDS stated he gave up and was taken into custody without incident. FIELDS acknowledged he was probably going to get some jail time because of the police pursuit and shooting in Maple Hts.

FIELDS stated he did not hear any gunshots and he was not present on McCurdy Avenue when CATCHINGS was shot by the Maple Hts Police Officer.

FIELDS stated he did not see where O [REDACTED] F [REDACTED] ran when the gold Ford Focus came to final rest after the accident.

FIELDS stated he did not know CATCHINGS real name and did not know anyone related to him. FIELDS stated he did not know CATCHINGS phone number and CATCHINGS phone number would be in his phone under "WHEAT"
