stated that she and Skylar Corbin (Corbin) were in a previous relationship for 10 years but broke up in September. Corbin ultimately left but she wanted out of the relationship due to his abusiveness.

stated that Corbin	came though the yard asking for to be with him.

stated that she was not going to be with him because he hasn't changed. Corbin stated, "Well then it's going to be a murder-suicide" to Corbin then took nd stuck a screwdriver to the back of her head and face. Corbin then took described and demonstrated that Corbin had her in a choke hold with his arm around her neck.
SA Holcomb asked more about when the deputies arrived on scene. "Well I seen the cops come rushing in, he [Corbin] was like 'there they are, this is going to be a murder-suicide' and I'm like 'oh my god' because he's always told me that. He's not going back to prison, that's what he's always said." stated that Corbin then had the screwdriver in his hand, and she put up her hands. She put up her hands because she knew he had a weapon, and the police might shoot.
stated that once the deputies got on scene, it was only a minute or two before they discharged their firearm. doesn't recall ever hearing the deputies say anything to Corbin when they arrived on scene. She stated, "They probably did but I'm just freaking out thinking I'm going to get shot, I'm going to get killed". The deputy then shot, and Corbin fell to the ground.
SA Holcomb asked fisher feared for her life. She replied, while becoming emotional, "Yes. Yes."
SA Holcomb asked where Gullett was during the incident. She said that she was near her car and then she walked away because he was getting so belligerent it was scary and was yelling very loudly. asked Gullett to call Corbin's mother, Maralynda Wilburn, to get him to go get mental health help.
When asked if Corbin has had any suicidal tendencies or talked about suicide before, stated he has talked about it; especially if she would ever leave him. She was not sure when he last talked about suicide but knew he had talked about it before.
stated that she believes Corbin has an active warrant but wasn't sure what it was for.
started dating a new person, Thibodaux, and when she started dating him that's when "all hell broke loose".
had a noticeable injury to her face. She wasn't exactly sure how she got the injury. SA Aja Chung with the BCI Crime Scene Unit documented the injury through photography.
SA Holcomb asked where her cell phone was. stated that a deputy had it. SA Holcomb said that her phone would be collected as evidence and if she would be willing to fill out a consent to search form for her cell phone. She agreed and signed the form. The form is attached to this report.
The interview concluded at approximately 0057 hours.
