Narrative:

On Tuesday, July 16, 2024, the Ohio Bureau of Criminal Investigation (BCI) was requested by Captain Eric C. Bors of the Medina County Sheriff's Office (MCSO) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved critical incident (shooting) which occurred in the area of 555 Independence Drive, Medina, Medina County, Ohio 44256.

BCI Special Agent (SA) Eric Lehnhart (SA Lehnhart) responded to assist, arriving at approximately 1930 hours. Also responding from BCI was SA John Tingley, SA Jack Shea, SA Joe Goudy and Assistant Superintendent Mark Kollar. Additionally, BCI Crime Scene Unit Special Agent Lurna McClintock and Evidence Technician Mike Rostocil processed the scene by documenting and collecting pertinent evidence. The officer-involved critical incident (shooting) involved a subject, Victoria Carter (Carter), and members of the MCSO. The incident resulted in the death of Carter.

Medina County Prosecutor Forrest Thompson was on scene prior to SA Lehnhart's arrival. Medina County Coroner Dr. Lisa Deranek, M.D. investigators arrived on scene to examine the decedent prior to the decedent being transported to Cuyahoga County Medical Examiner's Office for a post mortem examination.
