Narrative:

On April 11, 2024, North Olmsted Police **Constant Constant and Second Se**

ballistic vest carrier (Matrix Evidence Item #43):

- Four magazine pouches
- One handcuff case
- One radio earpiece.

SA Armstrong spoke with Ohio Assistant Attorney General (AAG) Micah Ault (Ault) and indicated the items had no evidentiary value to the investigation. AAG Ault indicated that the items could be released provided they were documented with photographs. A copy of the email indicating that the items could be released has been attached to this report.

SA Armstrong removed the items from the vest carrier, photographed them and turned them over to administrative professional Betsy Farris. The photographs have been attached to this report. At approximately 1353 hours, **Sector** picked up the items and signed a property receipt which has been attached to this report.

Administrative Professional Farris located the missing portion in the vest carrier, and it was turned over to
