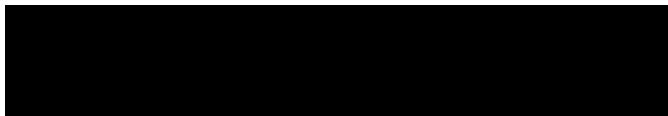

Narrative:

On Wednesday, April 2, 2025, the Ohio State Highway Patrol (OSHP) requested the Ohio Bureau of Criminal Investigation (BCI), to assist with an Officer-Involved Critical Incident that occurred at I-275 near SR-32, in Clermont County, Ohio. As part of the investigation, BCI Special Agent Lauren Frazier and BCI Crime Scene Technician (CST) Amy Cruely attended the post-mortem examination of the decedent, Kelsey Hildal. Also present was Clermont County Coroner Investigator Ken Mullis.

The examination was conducted on April 2, 2025, at the Hamilton County Coroner's Office, located at 4477 Carvers Woods Drive, Blue Ash, OH. The post mortem examination was conducted by Dr. Russell Uptegrove.

The following observations were made during the course of the autopsy:



SA Frazier requested to receive a copy of the full autopsy, death certificate, and toxicology reports once available.

As a result of the autopsy, evidence was collected and maintained by the Hamilton County Coroner's Office to dry. Evidentiary items were transferred to the custody of BCI CST Amy Cruely on April 3, 2025. The items were subsequently transported to the BCI Office in London, Ohio, where items were submitted to the BCI Laboratory and temporary evidence receiving. The evidence transfer sheet documenting these exchanges is attached to this investigative report (attachment #01).
