Narrative:

On April 20, 2021 at approximately 2345 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Jonathan Jenkins met with Shai-onta Craig and Tionna Bonner at the Columbus Police Department's (CPD) Substation 20, located at 2500 Park Crescent Drive, in Columbus, Ohio. During the meeting, Jenkins returned to Craig and Bonner their cellphones, which had been previously collected as evidence during an Officer Involved Critical Incident (OICI). The OICI involved Columbus Police Officer Nicholas Reardon and the shooting death of Ma'Khia Bryant. Bonner and Craig were both witnesses to the incident and as a result their cellphones were collected as potential evidence at the scene.

Upon meeting with Craig and Bonner at the CPD Substation 20, Jenkins escorted them to a conference room where the cellphones were located. Jenkins had previously met with Bonner and Craig at the scene of the incident to explain to them the reason their cellphones were being collected as evidence. Jenkins also notified Bonner and Craig that BCI Special Agent Supervisor Justin Root had finished his review of the cellphones and they could be returned. Prior to returning the cellphones, Bonner and Craig both signed a BCI Inventory Receipt Form documenting they took possession of their respective cellphones.
