Narrative:

On August 30, 2024, The Licking County Sheriff's Office (LCSO) requested the Ohio Bureau of Criminal Investigation (BCI) investigate an Officer-Involved Critical Incident (OICI) at 4206 Northridge Road, Alexandria, Ohio, involving officers with the LCSO, the Johnstown Police Department (JPD), and Doug Plott (Plott). Plott was ultimately shot by responding officers and succumbed to his injuries.

There were three initial responding officers. LCSO [REDACTED] and JPD [REDACTED] were identified as officers discharging their firearms during the incident with LCSO Deputy Nicholas Dewitt (Deputy Dewitt) being witness to the incident.

On September 9, 2024, [REDACTED] accompanied by Attorney Mark Volcheck, met with BCI Special Agents Craig Call (SA Call) and Aja Chung (SA Chung) in order to provide BCI with a statement of his involvement in the above incident.

During the interview, [REDACTED] disclosed he remembered issuing Plott a traffic citation earlier in 2024. [REDACTED] did not recall anything of note during the traffic stop, other than Plott telling him he had previously been in prison. [REDACTED] described the contact as a routine traffic stop.

JPD administrative staff provided SA Call with the traffic citation and body worn camera footage associated with the above traffic stop. The provided documentation indicates the stop occurred at approximately [REDACTED] hours on [REDACTED] at [REDACTED] Johnstown, Ohio. The disposition of the case indicates Plott was cited [REDACTED]

SA Call has reviewed the body worn camera footage associated with the above referenced stop and did not observe anything of note. [REDACTED] and Plott engaged in a conversational dialogue about the traffic stop and other unrelated occurrences in the Johnstown area. The body worn footage is approximately 26 minutes and 39 seconds in length and is stored in BCI's evidence.com.
