DEAR SIR: You have submitted for my examination and approval several land leases in triplicate, executed by the State of Ohio, through you as Conservation Commissioner, to Lillie Meyer and Henry G. Meyer of Dayton, Ohio, C. F. Berg and E. A. Wendelmoot and L. E. Schiffer of Lima, Ohio and Anna L. Herrier of Lakeview, Ohio.

By the lease executed to Lillie Meyer, which is one for a term of fifteen years and which provides for an annual rental of Twelve Dollars (\$12.00), there is leased and demised to the lessee named, the right to occupy and use for lawn, walkway and docklanding purposes only, that portion of the State reservoir property at Indian Lake, that lies in front of Lot No. 10 of Waterbury's allotment (unrecorded) and being that portion of the State land lying between the ordinary water line of Indian Lake; said Lot No. 10, has a total frontage of forty (40) feet, and being a part of the Virginia Military Surveys Nos. 10121, 9946 and 9925, Washington Township, Logan County, Ohio.
