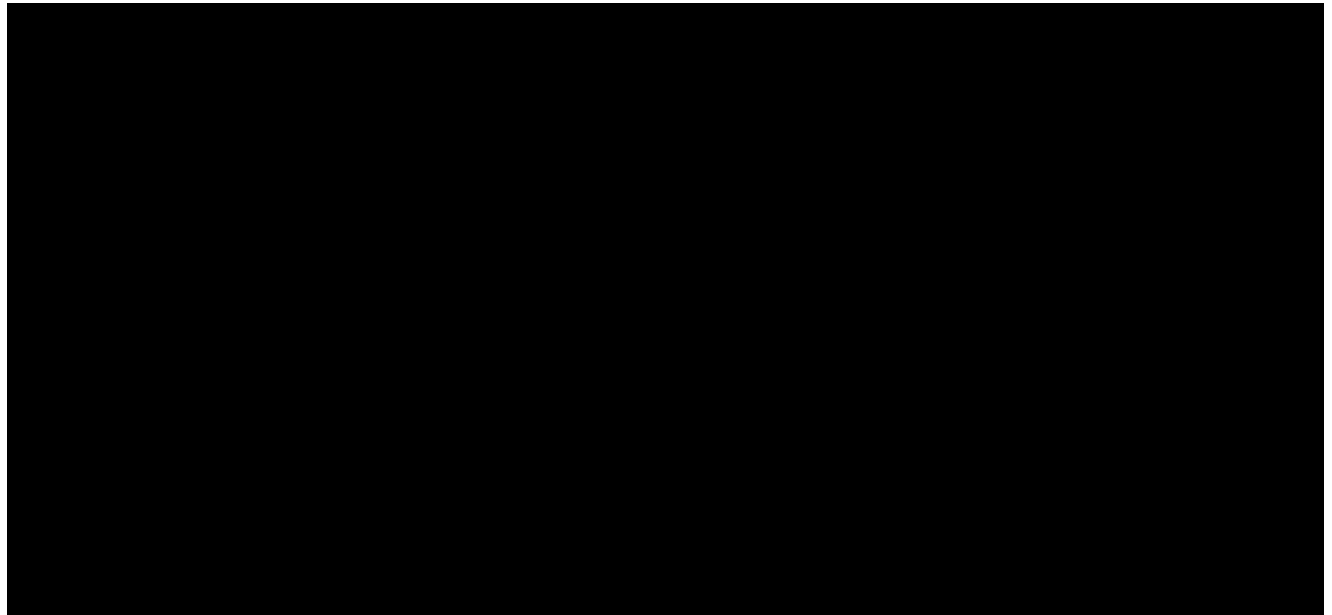

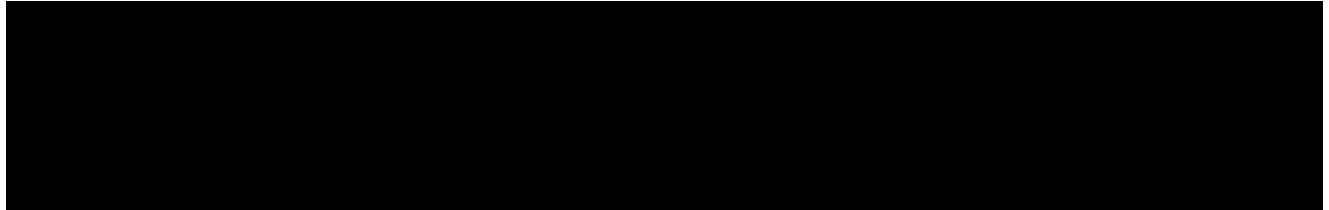

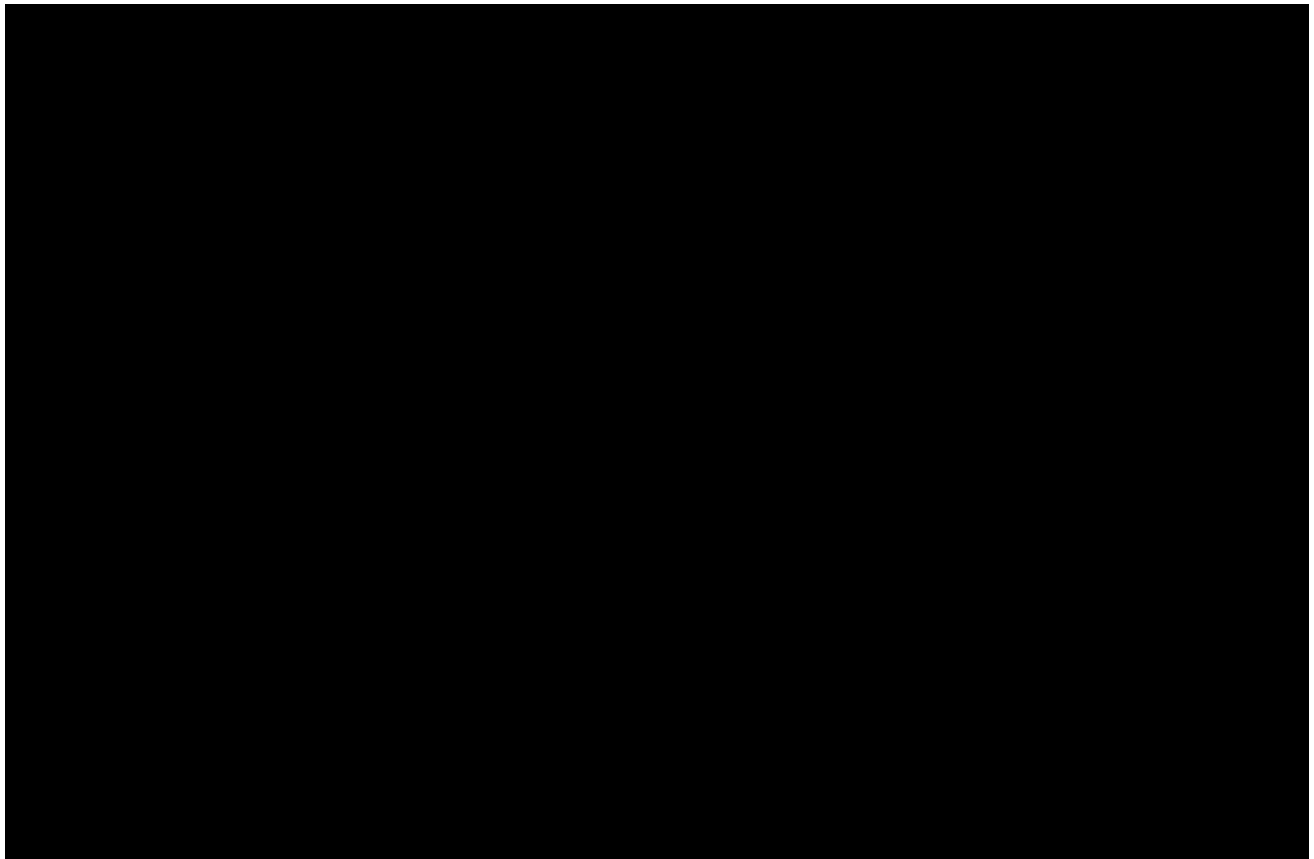

This matter came before the Court on the motion of **Katie Erchick Gilbert, City Prosecutor, of the Canton Prosecutor's Office**, for an Order compelling **Canton Fire/EMS**, to produce any and all reports for **Zachary James Fornash, dob: 07/18/1999, who was treated in the 800 and/or 900 block of Alan Page Dr SE on or about December 5, 2023.**

This Court finds that based upon specific facts articulated to the Court that there is reasonable grounds to believe that the records and/or information sought is relevant and material to an ongoing death investigation.
