

Narrative:

On May 22, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente received a PDF document containing a copy of the Flock camera images that captured the vehicle driven by subject Jason Norris (Norris) from North Ridgeville Police Records Clerk Brenda Girgash. The Flock camera images were attached to this report.

SA Valente reviewed the images and noted the following:

The subject vehicle was a silver Jeep Compass bearing Tennessee license plate "773BLYZ." All three Flock images captured the subject vehicle on May 8, 2024. The first Flock camera image captured the subject vehicle at 1754 hours while northbound on SR83. The subject vehicle was next captured at 1805 hours eastbound on US20 at Lear Nagle Road. The subject vehicle was last captured at 1812 hours while westbound on US 20 again at Lear Nagle Road. The images did not capture the operator or any potential passengers in the vehicle.






