Narrative:

On September 22, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier received requested records and recordings from Springfield Police Lieutenant Beau Collins. SA Frazier requested all Computer Aided Dispatch (CAD) records, audio recordings (radio, 911, and phone), and any other dispatch or communication-related information, related to the Officer-Involved Critical Incident that occurred on September 16, 2025. As a result of that request, the following items were received and reviewed:

Radio Traffic Recordings:

- One (1) audio file, totaling 4 minutes and 41 seconds was received. The file contained the radio traffic by officers related to this incident. The following information was noted, although the full audio should be reviewed:
 - 00:00 minute mark – [REDACTED] with radio call sign [REDACTED] requested that dispatch create and put him out on a traffic stop for a vehicle that fled. [REDACTED] described the vehicle as a silver F-250 with a temp tag in the rear window, and a White male driver who was bald.
 - 00:27 minute mark – [REDACTED] stated he would be out with the vehicle at Isabella and Pleasant, then advised that a white male was running south towards Clark.
 - 00:38 minute mark – [REDACTED] advised, "taser deployed."
 - Multiple officers said they were in route to the incident.
 - 00:53 minute mark – [REDACTED] requested a medic, stating that the male has a facial injury.
 - 01:18 minute mark – [REDACTED] asked the medics to pick it up, stating that the subject was losing a lot of blood.
 - 01:48 minute mark – [REDACTED] provided dispatch with a tag number for the vehicle, T854050.
 - 02:00 minute mark – Officer Ray requested where the medics were at. Dispatch stated they were five minutes out, coming from the 3000 block of East Main, and that they were the only medics available.
 - 02:36 minute mark – Officer Ray stated that the male was losing a lot of blood and going in and out of consciousness. He requested if officers could load him and take him to the hospital. The supervisor stated to do whatever they think is necessary.
 - 03:02 minute mark – Officers decide to load him up and told dispatch to keep medics in route.
 - 03:19 minute mark – 39P (Officer Massie) advised they were on their way to the

hospital with two officers riding in the back with the subject. He requested that dispatch contact the hospital to let them know they were in route.

- 04:24 minute mark – [REDACTED] stated that the vehicle was parked in front of 522 Isabella and the subject was located on the north East West alley.
