Narrative:

On Wednesday, November 20, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Douglas Burke (Burke) received documents from Hancock County Prosecutor's Office (HCPO) Prosecutor Investigator (PI) Thomas Blunk (Blunk) involving Kalvin Darapheth's (Kalvin) Juvenile criminal charge which had placed him on Juvenile Probation through Hancock County. SA Burke reviewed the documents which pertained to Kalvin being placed on Juvenile Probation through Hancock County for an incident which had occurred on February 12, 2022.

Below is a reviewed summary of the court documents received which involved Kalvin being placed on Juvenile Probation.

On February 12, 2022, Kalvin was criminally charged as an Alleged Delinquent Child in Hancock County Juvenile Court (HCJVC) for the Discharge of a Firearm at or into a habitation with the intent to cause harm or panic, a felony of the second (2nd) degree if committed by an adult. According to the criminal complaint, Kalvin discharged a rifle loaded with a .22 caliber bullet into an occupied residence belonging to Kenneth Silvers located at 628 College Street, Findlay, Hancock County, Ohio.

On June 2, 2022, Kalvin had a Change of Plea Hearing in HCJVC and accepted a plea of Attempted Discharge of a Firearm into a habitation, a felony of the third (3rd) degree if committed by an adult. Kalvin was ordered on Juvenile (JV) Probation through Hancock County and his JV Probation Officer (PO) was Jeff Azaroff (Azaroff).

On September 9, 2022, a JV Probation Violation was filed against Kalvin through HCJVC. On September 12, 2022, Kalvin went before the court and pleaded guilty to his said Probation Violation.

On September 7, 2023, Kalvin was successfully terminated from JV Probation through Hancock County. The termination of JV Probation was approved by Judge Kristen Johnson (Judge Johnson) and JVPO Azaroff. Once released from JV Probation, Kalvin had



A child cannot be required to a make a statement or give testimony at the hearing. You have the right to be confronted by witnesses, to question them and to call witnesses of your choosing.

JUDGMENT ENTRY

This matter came on before the Court on this 2nd day of June 2022 upon the Complaint filed herein. Said child appeared before the Court accompanied by his/her parent(s), and legal counsel Aaron Ried. Also present were Heather M. Pendleton, Hancock County Assistant Prosecuting Attorney, Jeff Azaroff, Probation Officer for this Court, and HCJFS, CPSU personnel.

Said child was advised of his/her legal and constitutional rights and to the nature of the Complaint and disposition the Court might make upon admission of the allegations herein, or a finding by the Court that said allegations were true. Further, the Court finds that said matter came within the provisions of the Juvenile Code of Ohio.

Pursuant to pretrial negotiations, the State moved to amend the charge to Attempted Discharge of a Firearm into a Habitation, a felony of the third degree if committed by an adult, and hearing no Objections, the Court GRANTS the motion.

Upon a formal reading of the amended Complaint, said child, through legal counsel, entered a plea of "admit" to the allegations herein. Being satisfied that said plea was voluntarily entered, and after a statement of facts from the Prosecutor, the Court finds KALVIN DARAPHETH is a DELINQUENT CHILD as defined by Ohio Revised Code Section 2152.02 and Sections 2923.02(A) and Section 2923.161(A)(1) Attempted Discharge of a Firearm into a Habitation, a felony of the third degree if committed by an adult.

The Court ORDERS said child shall be released from JDC today and immediately be placed on house arrest and electronic monitor.

The Court ORDERS said child shall successfully complete the 2022 Summer School program, provided enrollment is still open.

The Court ORDERS said child and parent(s) shall cooperate with the Juvenile Probation Department to complete an OYAS assessment and sign all necessary releases.

The Court ORDERS said child shall submit to fingerprinting.

The Court ORDERS said child shall refrain from using any illegal substances, vaping, and alcohol and shall submit to random drug screens as requested by the Juvenile Probation Department. Failure to appear or submit to a drug screen when requested will be considered a positive screen.

The Court ORDERS said child shall not use or have access to any firearms.

The Court ORDERS said child shall complete an intake assessment at the Family Resource Center of Northwest Ohio, Inc. (FRC) and follow all recommendations.

The Court ORDERS said child shall have no contact, direct or indirect, with Kobitee Bounchaleun, Conner Fleck, or Kenneth Silvers and his property.

The Court ORDERS said child shall not be permitted to visit his father, Thang Darapheth, unless the probation officer has given prior permission for said visits.

The Court ORDERS this matter continued for Disposition on July 20, 2022 at 10:00 a.m.

The Deputy Clerk of this Court is hereby ORDERED to serve a copy of the Judgment Entry/Order upon all parties or their counsel through the Court's e-filing system, Court correspondence drawers, regular U.S. mail, or facsimile and shall note the method of service upon the docket of this Court.

On this 05/25/2022 this matter came on for hearing pursuant to a Complaint filed 05/10/2022.

Said child appeared before this Court accompanied by his parents/guardians and legal counsel, Aaron Ried. Also present were Justin Kahle, Assistant Prosecuting Attorney, Jeff Azaroff, Probation Officer for this Court, and Katie Wood, HCJFS, CPSU.

Having been advised of his legal and constitutional rights, said child, through legal counsel, entered a plea of "deny" and the Court ORDERS this matter is hereby continued for TRIAL on JUNE 02, 2022 at 10:30 AM.

After inquiring as to the present circumstances of the youth, the Court finds that detention is required to protect the youth from immediate or threatened physical or emotional harm. Therefore, the Court ORDERS said child is remanded to the Wood County Juvenile Detention Center.

The Court find that removal is in the best interests of the child and that it would contrary to the welfare of the child to be returned home at this time. The Court also finds that reasonable efforts have been made to avoid the removing said child from his home.

The Deputy Clerk of this Court is hereby ORDERED to serve a copy of the Judgment Entry/Order upon all parties or their counsel through the Court's e-filing system, Court correspondence drawers, regular U.S. mail, or facsimile and shall note the method of service upon the docket of this Court.

JUDGMENT ENTRY

This matter came on before the Court on this 12th day of September 2022 upon an Affidavit of Violation of Probation filed September 9, 2022. Said child appeared before the Court accompanied by his/her parent(s), and legal counsel Aaron Ried. Also present were Heather M. Pendleton, Assistant Prosecuting Attorney, and Jeff Azaroff, Probation Officer for this Court.

Said child was advised of his/her legal and constitutional rights and to the nature of the Complaint and disposition the Court might make upon admission of the allegations herein, or a finding by the Court that said allegations were true. Further, the Court finds that said matter came within the provisions of the Juvenile Code of Ohio.

Upon a formal reading of the Complaint, said child entered a plea of "admit" to the allegations herein. Being satisfied that said plea was voluntarily entered, and a statement of facts, the Court finds KALVIN DARAPHETH is in violation of his/her probation previously Ordered on July 20, 2022.

The Court finds that removal is in the *best interests* of the child and that it would be *contrary to the welfare* of the child to be returned home at this time. The Court also finds that *reasonable efforts* have been made to avoid removing the child from their home.

The Court ORDERS said child shall serve three (3) days in the Wood County Juvenile Detention Center (JDC). Said child has served three (3) days in this matter. Therefore, said child shall be released to his mother at the conclusion of this hearing. Said child has previously served eight (8) days and currently served three (3) days in JDC, for a total of eleven (11) days served in this matter.

The Court ORDERS said child shall remain on probation in this matter with all prior Orders continuing in full force and effect, including said child's suspended six (6) month commitment to DYS.

The Court ORDERS said child shall not be permitted to take "open lunch" on school days.

The Court ORDERS said child shall not speak to anyone while in the bathrooms at school.

The Court ORDERS said child shall not have, use, or possess a vape or vaping product. Further, said child shall not be around anyone who has, uses, or possesses a vape or vaping product.

The Deputy Clerk of this Court is hereby ORDERED to serve a copy of the Judgment Entry/Order upon all parties or their counsel through the Court's e-filing system, Court correspondence drawers, regular U.S. mail, or facsimile and shall note the method of service upon the docket of this Court.
