## Narrative:

On May 13, 2024, at approximately 1207 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) received a copy of Officer Chrisopher Lewis' (Lewis), of the Elyria Police Department (EPD), body-worn camera footage from EPD Sergeant Richard Buckway (Buckway) via secure email.

The body-worn camera (BWC) footage for Officer Lewis was titled "Lewis\_OIS" and had a beginning time stamp of 2024-05-12 12:42:36 -0400 (Image #1). Officer Lewis' BWC footage was 5 hours, 34 minutes, and 40 seconds in duration.

It should be noted that SA Harasimchuk reviewed Officer Lewis' BWC footage in its entirety but only documented the moments immediately surrounding the time period when it is believed that **Sector 1** (**Sector 1**) (

At approximately 44 minutes and 5 seconds into Officer Lewis' BWC footage Officer Lewis' BWC is muted. Officer Lewis' BWC remained muted until approximately 1 hour, 20 minutes, and 5 seconds into the BWC footage (Time Stamp of 2024-05-12 14:02:42 - 0400). It is believed that EPD **Second State Problem Seconds** fired his **Seconds** through 1 hour, 10 minutes, and 36 seconds into **Second Second Second**

Refer to SA Harasimchuk's report titled, Video Review -- BWC, for further details. This time period would have had an approximate time stamp of 2024-05-12 16:40:43 -0400. During this time period, several loud noises and/or percussive sounds can then be heard. It is unknown if these sounds are other gunshots, less lethal munitions being fired, or another sound altogether. The view from Officer Lewis BWC during this time period can be seen in Image #3.
