DEAR SIR:—You have submitted for my approval contract between the State of Ohio, acting by the Department of Highways and Public Works, and John C. Klee of Sandusky, Ohio. This contract covers the construction and completion of circulating pump in power house and heating systems in Wards C, B, A, F, E and D, Ohio Soldiers' and Sailors' Home, Sandusky, Ohio, and calls for an expenditure of \$16,818.48.

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract.
