Narrative:

Special Agent Hammond received a call from Special Agent Supervisor Scott Stranahan requesting the crime scene unit to return to the scene on Tracy Road to recover the potential bullet(s) that may have struck the tree. He also requested that the side of the house located on Blue Jacket Drive be searched for potential bullet impacts during daylight. Special Agent Najmulski contacted management from Friendly Village and the owner of Unit #327 on Blue Jacket Drive who both gave consent for the crime scene unit to search these areas.

On May 29, 2024, at approximately 0745 hours, S/A Hammond and CST Miller arrived back at 27695 Tracy Road, Walbridge, Ohio. A daylight search was conducted by S/A Hammond and CST Miller. The weather at time of arrival was approximately 56 degrees Fahrenheit with rain. The scene was photographed as found.

Examination of the Tree

Two potential bullet impacts were located in a tree on the grass way located in front of Unit #327.

BI 1.0 was located approximately twenty-four inches (24") above the ground on the north side of the tree. This area of damage was visually consistent with a projectile or like object impacting the bark of the tree. The overall damaged area had a circular appearance. The area of the bark and wood beneath was excavated. No fired bullet or bullet paths were located.

One (1) additional area of potential impact approximately fifty inches (50") above the ground was examined by removing portions of the bark and sapwood of the tree. A fired bullet was not recovered.

It should be noted that the tree had numerous areas of damage that were consistent with chopping into the bark at the surface level. Someone living in the area alerted investigators that neighbor boys like to hit the tree with knives and other implements.

One fired cartridge casing **HORNADY 5.56 NATO** was located on the west slope of the ditch near the east side of house Unit #327 located on Blue Jacket Drive. The casing was placed into a manila envelope and sealed with clear tape. It was retained as evidence **(BCI Item A)**.
