#### Narrative:

On April 6, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) reviewed training, qualification, and personnel file records received from Columbus Division of Police (CPD) Sergeant Terry McConnell for CPD Officers James Ashenhurst (Officer Ashenhurst), Matthew Liford (Officer Liford), and Robert Cutshall (Officer Cutshall). After reviewing these records, SA Douglass noted the following:

#### Use of Force History:

Prior to the incident on February 11, 2023, Officer Ashenhurst had no records of "Sustained" or "Outside of Policy" use of force incidents.

Prior to the incident on February 11, 2023, Officer Liford had one record of "Sustained" use of force incidents on the following dates:

December 31, 2012

There were no indications that Officer Liford had been disciplined for his use of force on the dates of these incidents.


