**Narrative:**

On September 14, 2023, Ohio Bureau of Criminal identification and Investigation (BCI) Special Agent Ryan Scheiderer (SA Scheiderer) obtained an Investigative Subpoena from the Franklin County Municipal Court Duty Judge issued to Grant Medical Center (Grant) requesting their medical records for Antwan Lindsey (Lindsey) for July 08, 2023. On September 21, 2023, SA Scheiderer was notified the records were ready for pick up. The records were retrieved and reviewed. The following is a summation of what was observed within the records. Additional details can be found in the records which are attached to this report.

Lindsey arrived at Grant at approximately 2019 hours, via ambulance. Lindsey presented in traumatic cardiac arrest after gunshot wounds (GSW's) to the body. [REDACTED]
