Narrative:

On June 15, 2023, at approximately 1024 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) met with Cuyahoga County Medical Examiner's Office Evidence Technician Astra Driscoll (Driscoll). Driscoll provided SA Valente with 14 items consisting of DNA swabs and projectiles taken from Jeffrey Neff (Neff) at the time of the autopsy. A receipt was completed for the evidence transfer and was attached to this report.

SA Valente transported the 14 evidence items to BCI and placed them into temporary evidence locker #4, at 1130 hours.
