Narrative:

On Friday, January 7, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) received a copy of the Canton Fire Department (CFD) run report from Canton Police Department (CPD) Lieutenant Mark Kandel. The report was for the emergency run in response to the January 1, 2022, officer-involved shooting in Canton, Ohio. It was obtained via court order by the CPD. A copy of the run report and the court order has been attached to this report.

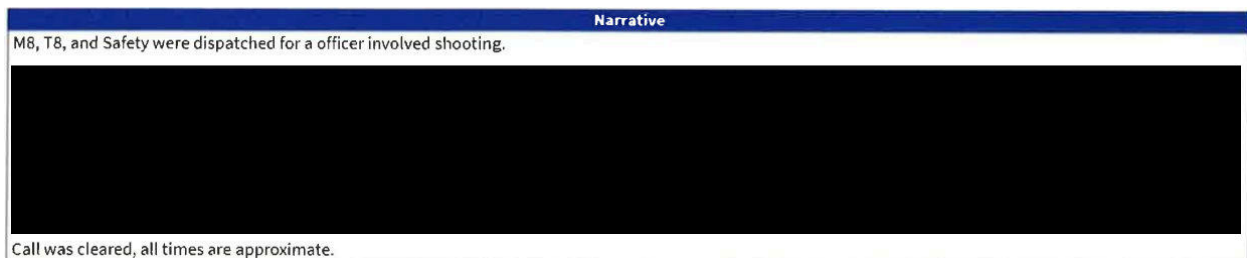
SA Tingley turned the report over to SA Matthew Armstrong, who reviewed it and noted the following:

CFD Incident #: 2022-00000003

The report contained six pages.

Page 1 – Contained Patient Information, Clinical Impression, Vitals, ECG (Electrocardiogram), Flow Chart and Assessment information. The patient was listed as James Williams; the Chief Complaint was listed as GSW (Gun Shot Wound), and the Rhythm under ECG was listed as Asystole.

Page 2 – Contained a continuation of the Assessment, Narrative, CPR information and Trauma Criteria. The Trauma Criteria indicated the patient was a trauma alert. The narrative from page 2 is depicted below:



Page 3 – Contained Incident Details, Destination Details and Incident Times. It also indicated the Ambulance Crew consisted of Mason Molina an EMT – Basic and Grant Holcomb an EMT – Paramedic. The Incident Details indicated the call was at 2307 10th Street SW, Canton, Ohio. The

This matter came before the Court on the motion of **Katie Erchick Gilbert, of the Canton City Prosecutor's Office** for an Order compelling **Canton Fire/EMS** to produce **any and all run records for James Williams, dob: 01/13/1975, who was treated in the 2300 block of 10th St SW and ultimately transported to Aultman Hospital on or about January 1, 2022.**

This Court finds that based upon specific facts articulated to the Court that there is reasonable grounds to believe that the records and/or information sought is relevant and material to an ongoing death investigation.

It is accordingly ordered and adjudged that **Canton Fire/EMS** shall produce the requested records to **Katie Erchick Gilbert, of the Canton City Prosecutor's Office** within three (3) business days.
