<u>Summary:</u>

On June 21, 2021, Special Agent Jared Prill of the Ohio Bureau of Criminal Investigation received consent to search the contents of a ZTE mobile phone from Rosanne Couture. This item was to be analyzed for evidence relating to the crime of Officer Involved Critical Incident regarding the subject Kevin Giesel.

Submitted Items:

019 - Mobile Phone - ZTE Majesty Pro - Z899VL

<u>Details:</u>

Item 19: **Item 19** is a ZTE manufactured mobile phone model Z899VL (Majesty Pro) bearing the International Mobile Equipment Identity (IMEI) number 990008867581584 and the serial number 32F483713863. **Item 19** has an advertised internal storage capacity of 16 Gigabytes (GB) and is capable of additional storage through the use of a micro Secure Digital (SD) card. No additional storage was submitted with **Item 19**. **Item 19** was placed into Airplane mode to suspend wireless communications. Logical and file system extractions were performed using the Cellebrite manufactured Universal Forensic Extraction Device (UFED) 4PC. These extractions were then loaded into Cellebrite Physical Analyzer, a software package that converts that data to an easily readable format.

Item 19a: Item 19a is a Tracfone branded Subscriber Identity Module (SIM) card bearing the Integrated Circuit Card Identifier (ICCID) 89148000004152395540.
