DEAR SIR:—You have submitted for my examination and approval, a contract between the State of Ohio, acting by and through the Department of Public Works, for and on behalf of the Board of Trustees of Miami University, Oxford, Ohio, and Fosdick and Hilmer, of Cincinnati, Ohio, for architectural services in connection with the remodeling and fireproofing of South Dormitory Building, Miami University, Oxford, Ohio, and providing for compensation to the architect in an amount equal to six per cent (6%) of the amount paid out by the Board of Trustees under and on account of contracts entered into by the State for the construction of said improvement.

You have also submitted a certificate signed by the Secretary of the Board of Trustees of Miami University, showing that a sufficient amount is
