DEAR SIR: This is to acknowledge the receipt of your recent communication with which you submit for my examination and approval a canal land lease in triplicate executed by you as Superintendent of Public Works and as Director of said Department, acting for the state of Ohio, to one Joseph R. Cromes of Tippecanoe City, Ohio. By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$15.00 payable in semiannual installments of \$7.50 each, there is leased and demised to the lessee above named the right to occupy and use for agricultural and cottage purposes, that portion of the abandoned Miami and Erie Canal property, including the full width of the bed and banks thereof, located in Concord Township, Miami County, Ohio, and described as follows:
