Narrative:

On June 27 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent Tiffany Vollmer received requested records and recordings from the Allen County Sheriff's Office pertaining to the Officer Involved Shooting that occurred on June 21, 2022 in Lima, Ohio. Investigators had previously requested all dispatch records, audio recordings (radio, 911 and phone), mobile data terminal (MDT) communications and any other dispatch/communications-related information for the the incident that occurred on June 21, 2022. As a result of that request, the following items were received and reviewed:

Computer Aided Dispatch (CAD) Records:

Special Agent Supervisor (SAS) Scott Stranahan reviewed the information provided by the Allen County Sheriff's Office (ACSO) pertaining to dispatch logs and Computer Aided Dispatch (CAD) reports. The information provided appeared to document the times and duration of radio transmissions. The log also showed which Channel the radio traffic occurred on. The information was contained in two documents showing the same information. The first document is contained under the file name "2022_10353-CDR.pdf." The second document is listed under file name "full_audio_no_skipped_silence-CDR.pdf." Neither of these documents show any dispatch or CAD notes.

On July 6, 2022, ACSO Lieutenant (Lt.) Bret Rider provided SAS Stranahan with an 18 page document that contained the ACSO Dispatch notes and CAD records for the time of this incident. SAS Stranahan reviewed the information and noted the following:

The Dispatch Incident Report indicated the event was created on June 21, 2022 at 2:35:20 A.M. The location of the incident was listed as E. 2nd Street / S. Sugar Street in Lima, Ohio. The incident type was listed as Traffic Stop.

The dispatch records indicated the following personnel had radio traffic during and following this incident:

Radio Traffic Recordings:

SAS Stranahan next reviewed the dispatch audio recordings received from the ACSO regarding this incident. There were two files that each contained the same radio traffic. The first file, titled "2022_10353" contained dispatch audio with pauses between radio transmissions. The second file, titled "full_audio_no_skipped_silence" also contained radio traffic from this incident and as stated, contained no pauses between transmissions. It was noted that some of the radio traffic contained various police radio "10" codes. SAS Stranahan obtained a copy of the "10 codes" used by the ACSO which are attached to this investigative report as a reference guide when reviewing the radio transmissions. Investigation revealed the following:

- The radio transmissions began with Deputy Ackerman calling out a traffic stop:

"227 attempting a 10-62 on second street" (Note: The code 10-62 refers to a traffic stop.)

- There is a short pause and Deputy Ackerman continues:

"Go eastbound coming up to Sugar right now." Dispatch responds and says "10-3" (Note: the code 10-3 is dispatch "Acknowledging" Deputy Ackerman's radio traffic.)

- After a brief pause, Deputy Ackerman's next radio transmission said:

"Ran the stop sign, northbound on Sugar." It was during this radio transmission that SAS Stranahan was able to hear an audible siren.

- Deputy Ackerman next said:

"Through an alley just north of Second Street, from Sugar, westbound." SAS Stranahan was able to hear an audible siren in the background of this radio transmission.

- After a brief pause, Deputy Ackerman's next radio transmission said:

"Running southbound. Show me your fucking hands. Stop! Stop! Show me your hands right now! Do you..." The radio transmission ended abruptly. During this transmission, Deputy Ackerman's tone of voice changed as he was now yelling verbal commands.

- After a very short pause, the dispatcher said:

"Any unit available to back 227?".

- Deputy Ackerman then said:

"227, shots fired! I'm hit!" A brief pause and then "Start 10-30!" (Note: the code 10-30 refers to "Rescue Needed.") Another short pause and then: "I don't know where I'm hit, but somewhere in the, in the face. Start 10-30."

- Another male voice said:

"...[Unintelligible] down there" (SAS Stranahan was able to hear an audible siren in the background of this brief radio transmission).

- Deputy Ackerman said:

"I'm by my cruiser."

- Lieutenant Butler (Patrol supervisor) said:

"240, make sure you are getting a hold of the city [City of Lima Police Department]." Dispatch acknowledged this transmission and said "Clear."

- Deputy Ackerman said:

"Subject's down. But, I'm bleeding." There is a brief pause, then Deputy Ackerman said: "We're in an alleyway west of Sugar, north of Second Street." SAS Stranahan noted that during this series of radio transmissions, Deputy Ackerman was breathing heavily.

- Another Deputy, (possibly a supervisor) said:

"240, They got squad 43?" (Note: the radio code 10-43 refers to "Enroute to Assigned Assignment." The dispatcher immediately responded and said "10-34" (Note: radio code 10-34 refers to an "Affirmative Response."). The same Deputy then broadcasts: "240, to 21...you guys slow down."

- Lieutenant Butler (Patrol supervisor) said:

"240," The dispatcher immediately responded and said "240." The Deputy then said "If he did not give you a 10-32 (Note: radio code 10-32 refers to a Driver's License or Vehicle Registration Check), just mark and hold down, I don't need it back at this time...John, Nora, John, 8296. JNJ-8296. The dispatcher immediately responded and said: "You're clear."

- Another responding Deputy said:

"240." Lieutenant Butler then said: "go ahead." The Deputy then said: "See what he [Ackerman] did, if he could tell you what he did with his 57 (Note: radio code 10-57 refers to "Felonious Assault Complaint." Additionally, radio code 10-57A refers to "Felonious Assault with Weapons."). Another Deputy immediately responds and said: "I put it in the trunk of his

unit." Based on the context of these radio transmissions coupled with observations at the scene, it is clear that the Deputies are asking where Deputy Ackerman's firearm was secured and it was reported that Deputy Ackerman's firearm was secured in the trunk/cargo area of his assigned patrol vehicle. It should be noted that Deputy Ackerman's firearm was in fact located in the trunk/cargo area of his assigned patrol vehicle.

- Deputy Hanjora said:

"224. Did you get his 32" (Note: radio code 10-32 is a reference to a Driver's License or Vehicle Registration Check). The dispatcher attempted to respond but the dispatcher's radio mic was opened and closed with nothing said. The Deputy then asked: "Can we have that back?" The dispatcher replied and said: "10-34 (Note: radio code 10-34 is a reference to an "Affirmative Response.") Comes back to a Latone Perry. 1132 Essex. It's gonna be on a red, 2003, Buick. He is showing suspended [Note: in this transmission the word suspended is most likely a reference to the vehicle owner's driving status with the Ohio Bureau of Motor Vehicles.).

- Lieutenant Butler (Patrol supervisor) said:

"240 to 25."

- Deputy Hanjora then said:

"24." The dispatcher immediately responds and said: "224." The Deputy then said: "LPD [Lima Police Department] has agreed to handle our calls for the time being." The dispatcher immediately responded and said: "10-3" (Note: radio code 10-3, means "Acknowledge.").

The remainder of the radio traffic provided by the ACSO, contains various Deputies responding to unrelated calls for service or arriving at the scene of this incident. For further details, it is suggested that the reader refer to the attached audio file(s).

Mobile Data Terminal (MDT) Communications:

On July 6, 2022, SAS Stranahan spoke with Detective Lieutenant (Lt.) Bret Rider of the ACSO concerning Mobile Data Terminal (MDT) Communications. During the conversation, Lt. Rider provided the following information. Lt. Rider explained that when he spoke with the ACSO Information Technology Department (IT) regarding the MDT communications, he learned that their system records over itself and there was no way to provide BCI a product that would show any MDT communications at the time of this incident. Lt. Rider was unable to provide any additional details.
