Narrative:

On Friday, September 13, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Eric Lehnhart (Lehnhart) received an email from the Cuyahoga County Medical Examiner’s Office (CCME). The correspondence consisted of the autopsy report for Shannon Sloan.

On Tuesday, September 19, 2024, SA Allison Fletcher (Fletcher) received an email from the Medina County Coroner’s Office. The correspondence consisted of the “Coroner’s Comprehensive Report of Death Investigation” completed by Medina County Coroner Doctor Lisa Deranek, M.D (Deranek).
