NARRATIVE

Menacing

On Saturday, May 7th, 2022, while assigned to z/c 5D33, I (P.O. Jereb #1204), received a radio assignment at approximately 0934hrs to respond the location of 1120 E 67th St. for a threats report. Upon my arrival, I was met by Robert Perkins and [REDACTED]. Below are the following details of the incident.

While on scene, I spoke to Robert and [REDACTED] in regards to the on going issues they have been having with the neighbors at 1116 E 67th St. This morning, while Robert was sitting on his front porch, he explained to me that an unknown male made a comment to him in regards to the sign he has in his front yard. The male expressed to Robert that he needs to take the sign down and wanted to argue with Robert about it. Robert made numerous attempts to de-escalate the situation. At one point during the conversation, the male told Robert that "he will not be here tomorrow" and that he is going to "burn your place down".

Robert has video footage of the threats made. I was able to watch the video and attempted to record the footage on my WCS. Robert believes that the threats may not be real, but still wanted to make a report of the male threatening him. Robert and [REDACTED] were given a copy of the incident number and advised to call the police if any issues arise.
