DEAR SIR:—You have submitted for my examination and opinion a contract between Bruce Wilder Saville, of New York City, and the State of Ohio, acting by the Department of Public Works. This contract covers the employment of Bruce Wilder Saville, as sculptor, for the erection and construction of a bronze group as part of the monument to commemorate the victory of General Wayne on the Battlefield of Fallen Timbers, and involving an expenditure of Fourteen Thousand Seven Hundred and Fifty (\$14,750.00) dollars.

Inasmuch as the work covered by the above contract is of such a character that it was impracticable to advertise for and receive competitive bids therefor, the advertising for bids and the tabulation of bids were dispensed with. You have, however, furnished evidence that the Controlling Board has given its consent to the expenditure of the money for said contract, as required by Section 12 of House Bill No. 502 of the 87th General Assembly, and also an encumbrance estimate certified by the Director of Finance to the effect that there are unencumbered balances legally appropriated in an amount sufficient to cover the obligation of said contract.
