Narrative:

On Wednesday, October 1, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Dan Boerner (SA Boerner) assisted Special Agent Joe Lamping (SA Lamping) with reviewing the dash cam recordings of Ashtabula County Sheriff's Office (ACSO) [REDACTED] in regard to an officer-involved critical incident that took place on Monday, September 8, 2025, in Denmark Township, Ohio. The dash cam recording was uploaded to Axon Justice on Wednesday, September 10, 2025, by Lieutenant Matt Johns (Lt.
