**Narrative:**

On Thursday, August 29, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) reviewed body-camera video footage from Medina Police Department (MPD) Sergeant Raven Ory (Ory). The video footage is related to the officer involved critical incident which took place on July 17, 2024, at 555 Independence Drive, Medina, Medina County, Ohio. The incident involved Victoria Carter (Carter) and members of the Medina County Sheriff's Office (MCSO) and resulted in the death of Carter.

The listed narrative is a synopsis of the activities and conversations recorded on Sergeant Ory's Body Worn Camera and only documents those activities which the author deems to be the most relevant. Furthermore, the narrative does not cover all of the activities or conversations of Sergeant Ory's, the members of the MCSO and the Medina LST EMS personnel which were recorded nor all of the comments made by Sergeant Ory, members of the MCSO or Medina LST personnel. It is suggested that the full recordings be reviewed to clarify any content or contextual questions regarding the information documented in the narrative.

SA Tingley reviewed the Body Camera video recordings listed as Raven Ory\_202407171804\_BWL7018119-0 and noted the following:

The video began on 07/17/2024 at 18:04:40 hours and is 0:34:29 in length. The video began with Sergeant Ory driving. Initially there was no audio.

At approximately 18:05:10 hours, the audio was activated.

At approximately 18:07:27 hours, Sergeant Ory arrived at the MCSO and exited her cruiser.

Sergeant Ory then approached the incident scene, which was taped off. An unknown MCSO Deputy then asked her to start and keep the crime scene log.

At approximately 18:08:38 hours, Sergeant Ory began the crime scene log.

The remainder of the video is of Sergeant Ory keeping up on the crime scene log and helping to maintain scene security.

The video then concluded with Sergeant Ory standing in the drive just outside the crime scene perimeter.

SA Tingley reviewed the Body Camera video recordings listed as Raven Ory\_202407171920\_BWL7018119-0 and noted the following:

The video began on 07/17/2024 at 19:20:16 hours and is 0:02:55 in length. The video began with Sergeant Ory standing in the parking lot of the MCSO. Initially there was no audio.

This video had no relevant information related to the officer involved critical incident.

SA Tingley reviewed the Body Camera video recordings listed as Raven Ory\_202407171937\_BWL7018119-0 and noted the following:

The video began on 07/17/2024 at 19:37:25 hours and was 0:02:32 in length. The video began with Sergeant Ory standing in the parking lot of the MCSO. Initially there was no audio.

This video had no relevant information related to the officer involved critical incident.

SA Tingley reviewed the Body Camera video recordings listed as Raven Ory\_202407172005\_BWL7018119-0 and noted the following:

The video began on 07/17/2024 at 20:05:25 hours and was 0:01:13 in length. The video began with Sergeant Ory standing in the parking lot of the MCSO. Initially there was no audio.

This video had no relevant information related to the officer involved critical incident.

SA Tingley reviewed the Body Camera video recordings listed as Raven Ory\_202407171920\_BWL7018119-0 and noted the following:

The video began on 07/17/2131 at 21:31:12 hours and was 0:001:01 in length. The video began with Sergeant Ory standing in the parking lot of the MCSO. Initially there was no audio.

This video had no relevant information related to the officer involved critical incident.
