**Narrative:**

On Tuesday, September 16, 2025, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Springfield Police Department, to conduct an independent investigation of the facts and circumstances surrounding an Officer-Involved Critical Incident (OICI) that occurred near 513 South Isabella Street in Springfield, Clark County, Ohio.

Ohio BCI Special Agent Lauren Frazier was assigned as the Lead Case Agent. BCI Special Agent Steven Seitzman assisted with the investigation. The investigation was supervised by BCI Special Agent Supervisors William Jones and Kevin Barbeau. Additionally, the BCI Crime Scene Unit (CSU) was requested to process the scene, by documenting and collecting pertinent evidence. Crime Scene Special Agent Aja Chung was the Lead Agent for crime scene.

The OICI incident involved a subject, Patrick Foley (Foley), and an officer with the Springfield Police Department, [REDACTED]. Additional responding officers included Springfield Police Officer Zachary Massie, Detective Joshua Emory, Officer Beau Ray, Officer Brad Warnock, and Officer Kristopher Kitchen. The incident resulted in the subject being in critical medical condition. On September 19, 2025, Foley was determined to be brain dead and pronounced deceased.

The following is an initial summary of the incident:

On September 16, 2025 at approximately 1134 hours, Springfield Police [REDACTED] attempted to initiate a traffic stop on a silver Ford truck, for a speeding violation. The vehicle took off at a high speed and fled from the traffic stop. [REDACTED] discontinued the traffic stop and attempted to locate the vehicle in the area.

At approximately 1138 hours, [REDACTED] located the silver Ford truck at South Isabella Street near East Pleasant Street. A white male subject, later identified as Patrick Foley, fled

from the vehicle on foot. [REDACTED] began to pursue Foley on foot. During the brief foot pursuit, [REDACTED] deployed his department-issued Taser, which incapacitated the subject while he was running. The Taser was effective and Foley fell to the ground and sustained injuries to his head and face.

Officers immediately called for a medic to respond and began providing medical intervention to the subject. Due to the subject's injuries and medics being located further away, the decision was made for officers to transport the subject. The subject was placed in the back of Springfield Police Van 40 and transported to Springfield Regional Medical Center (SRMC). The subject was then transported via medical helicopter to Miami Valley Hospital in critical medical condition. On September 19, 2025, Foley was determined to be brain dead and pronounced deceased.

It was later determined that a female passenger also fled from the vehicle and was identified as Tyvonda Lynn Jones. Reportedly, the female did not observe the OICI involving Foley.

BCI is investigating the Officer-Involved Critical Incident. Springfield Police Department handled any criminal charges against the subject. Springfield Police Detective Josh Lish wrote a search warrant for the vehicle involved, which has been attached to this report. It was noted that narcotics were located on the subject and inside of the vehicle.

Springfield Police Department provided a Request for Assistance letter, which has been attached to this report.

# SEARCH WARRANT

IN THE MATTER OF SEARCH OF: **A silver 2008 Ford F-250, bearing OH registration T854050, with VIN: 1FTSX21508EC21767, currently being held at Maines Towing, 1717 E Pleasant St., Springfield, Clark County, OH.**

STATE OF OHIO, CLARK COUNTY, SS:

TO **Chief Allison Elliott, Detective Joshua Lish**, and all other law enforcement officers:

WHEREAS, there appeared personally or by an approved electronic means before me one **Detective Joshua Lish** and swore to the facts set forth in an Affidavit on file with the Court in this matter.

WHEREAS, I find from said Affidavit that there is probable cause to believe:

- I. That in the CITY/VILLAGE/TOWNSHIP of **Springfield**, Clark County, Ohio, the following criminal offense(s) have occurred:

2921.331 Failure to Comply with Order or Signal of Police Officer  
2925.11 Trafficking Drugs

- II. That the following described items of property are connected with the commission of said offense(s):

Suspected drugs, scales, firearms, ammunition, cell phones, and any other evidence of trafficking drugs.

- III. That the said items of property are concealed either upon the persons and/or at the places:

**A silver 2008 Ford F-250, bearing OH registration T854050, with VIN: 1FTSX21508EC21767, currently being held at Maines Towing, 1717 E Pleasant St., Springfield, Clark County, OH.**


NOW, THEREFORE, you are hereby COMMANDED, in the name of the State of Ohio, with necessary and proper assistance from BCI, within the next three days (excluding Saturday, Sunday, and any legal holidays), to enter into the place or places described in Paragraph III above, and there diligently search for the property described in Paragraph II above. I find that there is reasonable cause to justify and hereby authorize execution of this Warrant during the **daytime**. Within the territorial jurisdiction of this Court, you are authorized to search the person(s) described in Paragraph III above for items of property described in Paragraph II above. Of this Warrant make due return to the undersigned, accompanied by an inventory of any property seized.

All property seized pursuant to this Warrant shall be forthwith delivered into the custody of the Police Department Evidence Custodian to be held as evidence or until further Order of this Court.

The facts upon which the affiant relies and bases his/her belief that said items of property and things are so unlawfully concealed are contained in Paragraph IV of the affidavit which is filed in support of this Warrant and is incorporated herein.

## AFFIDAVIT (For Search Warrant)

IN THE MATTER OF SEARCH OF: A silver 2008 Ford F-250, bearing OH registration T854050, with VIN: 1FTSX21508EC21767, currently being held at Maines Towing, 1717 E Pleasant St., Springfield, Clark County, OH.

STATE OF OHIO, CLARK COUNTY, SS:

Before me, the undersigned Judge, personally appeared **Detective Joshua Lish** (affiant), who being first duly cautioned and sworn on oath, deposes and says:

- I. That in the CITY/VILLAGE/TOWNSHIP of **Springfield**, Clark County, Ohio, the criminal offense(s) as listed in Paragraph "I" of the Search Warrant in this matter have occurred.
- II. That Affiant requests the issuance of a Search Warrant for the items of property listed in Paragraph "II" of the Search Warrant in this matter.
- III. That the said items of property are concealed upon the person(s) described and/or the place(s) described in Paragraph "III" of the Search Warrant in this matter.
- IV. That the facts upon which the Affiant bases said beliefs are:

On 09/16/2025 at approximately 1134 hours, [REDACTED] of the Springfield Police Division, attempted to make a traffic stop on a silver Ford truck in the area of E. Perrin Av. at S. Limestone St. [REDACTED] clocked the vehicle at 62 mph in a 35 mph zone with his laser. [REDACTED] initiated his overhead lights and siren to initiate a traffic stop. The vehicle fled from the traffic stop.

At approximately 1138 hours, [REDACTED] relocated the vehicle in the area of S. Isabella St. near E. Pleasant St. A white male fled from the vehicle on foot. As the male was fleeing, [REDACTED] deployed his department issued Taser on the male. The Taser was effective and appeared to cause neuromuscular incapacitation as the male fell to the ground and appeared to strike his head on the ground. Officers called for a medic immediately as officers reported the male was in and out of consciousness. Officers located a white rock like substance on the male as they were checking him for injuries. Do to the amount of blood loss, officers loaded the male into Springfield Police Van 40 and transported him to Springfield Regional Medical Center (SRMC) for treatment. The male was later transported to Miami Valley Hospital for treatment.

The truck was stopped in front of 522 S. Isabella St. The vehicle was identified as a silver 2008 Ford F-250. The truck was bearing OH registration T854050 and a VIN of 1FTSX21508EC21767. In plain view in the vehicle, there appears to be marijuana roaches in the ashtray. There is also a Crown Royal bag in the center console in plain sight. Based on my knowledge, training, and experience, I know it to be very popular to keep illegal drugs in Crown Royal bags. I also know firearms are often involved in trafficking drugs. The vehicle will be towed from the scene by Maines Towing. It will be held as evidence at 1717 E Pleasant St. in Springfield, OH.

The Springfield Police Division requested the Ohio Attorney General's Bureau of Criminal Investigation and Identification (BCI) to respond to the scene to investigate the use of force. Detectives now wish to search the 2008 Ford F-250, bearing OH registration T854050, being held at Maines Towing for any firearms, ammunition, suspected drugs, cell phones, and any other evidence of trafficking drug.

Based upon the above facts and beliefs, Affiant requests that a Warrant be issued to the proper police authority authorizing a personal search of the person(s) above described for the items and things named, and for a search of the described places and things for said items of property; and, if said items of property, or any part thereof, are found in the places or in the things described, or upon the person(s) described, authority is requested to seize said items of property which may be found and to seize the described person(s) in unlawful possession of or in unlawful control of said items of property.

Affiant says there is no urgent necessity for a nighttime search.
